The Trustees and the management committee of Wandsworth Care Alliance takes pleasure in presenting the Executive Committee's Report and the audited financial statement for the year ended 31 March 2014.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Companies Act 2006 and the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005.

The Company's directors are also trustees of the charity, however not all trustees are directors. The Board has the power to appoint additional trustees as required by the organisation.

WCA was founded in 1991 and was governed by its constitution until its date of incorporation.

The company was incorporated on the 14th April 2004 and was not a registered charity until the 23rd June 2005.

The memorandum and articles of association empowers the Board of Trustees, which is collectively represented by the membership at the Annual General Meeting, with decision making.

### **Objectives and activities**

The objectives of the charity (the "Objects") are the relief of sickness and the preservation of good health and well being including without limitation by the provision of information and advice and by providing an independent voluntary sector voice, and by monitoring, reviewing and seeking to contribute to the improvement of health and social care services, in particular, but not exclusively, for people from minority groups and their carers.

#### **Achievements and performance**

Our projects continue to perform well and are viable, however funding for core costs remains a particular challenge for us, as it does for many similar organisations in the voluntary sector. The organisation ran a deficit of c£46k, eating into reserves. A reasonable proportion of the deficit can be explained by the challenges of meeting core costs in the period, augmented by the contingency costs of covering some long-term staff sickness. But as described last year we had significant costs relating to unexpected circumstances and events in 2012/13 which were not within our control. Some of these costs appear in the accounts for 2013/14.

Healthwatch has had a successful first year thanks to the dedicated staff and the enormous contribution of volunteers and voluntary representatives. The first year has been financially viable, securing approximately 70% of possible performance related payments. Feedback about Healthwatch from members and stakeholders has generally been very positive reflected in the first Healthwatch annual survey.

Social Sundayz (a peer lead social club for service users) has been successfully set up and is functioning as service user led and operated project supported by WCA. Further funding has been secured for the whole of 2014/15 (until end March 2015) and operations have expended for the original Sunday afternoon session to included an additional Thursday evening session of the social club.

The Seldom Heard Groups project supported over 20 seldom heard groups in the 2013/14 period and funding has been secured for 2014/15.

As a direct result of the work of the North Battersea Audit we have secured a small amount of funding for a Skill Swap pilot. Work will be carried out in 2014/15.

#### **Financial review**

Income for the year ending 31st March 2014 was £405,536, an increase of £41,507 (11.4%) on the previous year. However our expenditure also rose by £55,093 from £396,882 in 2012/13 to £451,975 in 2013/14. Generally speaking expenditure has grown due to required changes in staffing levels, necessary restructuring and responding to a legal challenge that began in the 2012/13 reporting period.

#### **Reserve policy**

The present level of funding is adequate to support the continuation of the charity's operations, and the trustees consider the financial position of the charity to be satisfactory.

The trustees have agreed that the organisation will maintain a level of reserves that is subject to review on a quarterly basis to ensure it is satisfactory and would enable them to meet their financial obligations.

The trustees are empowered to take the course of action that they consider appropriate to further the company's charitable objectives.

#### **Plans for the future**

Healthwatch continues to provide some security of income for at least the next two years. Restructuring will bring some staffing cost efficiencies that we should begin to feel in the coming year. We intend to build on the success of our volunteer coordinator activities and aim to fundraise to secure longer term funding for this function.

### **Statement of Trustees responsibilities**

The Directors and Trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the accounts comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.


### **Disclosure of information to auditors**

#### 1 Accounting policies

##### 1.1 Basis of preparation

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and the Companies Act 2006.

##### 1.2 Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of service level contracts, grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Contract Income generated for services rendered are recorded in the accounts when the invoices have been raised and excludes any VAT.

Investment income is included when receivable.

##### 1.3 Resources expended

Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the audit fees and costs linked to the strategic management of the charity.

##### 1.4 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:
