The Chairman stated that such a notice could not be displayed in the name of the Council but there was nothing preventing a private notice appearing on the notice board.

[c] Closure of Bonvilston Lay-by. A reply from the Vale of Glamorgan Council was read indicating that the area referred to did not constitute an official lay-by and there were no objections to the highway works for the access.
