[9] TO ACCEPT REPORTS FROM:-

[a] County Borough Councillor -

CB Cllr Bird — Reported the following: (i) Redrow had lost the appeal to retain the advertising hoarding on Redlands Farm land. This will now have to be removed. (ii) There is an increased incidence of fly tipping. CB Cllr Bird is encouraging the Council to take an initiative to seek prosecutions, perhaps with the assistance of mobile number plate recognition units. (iii) He has followed up the enquiry regarding the 'driveway', crossing council owned land, which has appeared in Maes y Ffynnon. A response is awaited from Highways.

[b] Community Councillors

Cllr Jones raised concerns at the 'For Sale' signs at the entrance to Rectory Close, St Nicholas. A response had been received from Planning and had been raised with Highways with no action taken. It was agreed that this matter be taken up with the Estate Agents directly. *Cllr Fisher* to follow it up.

Cllr Fuller raised concerns that residents opposite the new Redrow Development believed that they may be unable to turn right to Cardiff in the future. CB Cllr Bird did not believe this to be the case and would confirm.. *CB Cllr Bird* to raise with Highways.

Cllr Fuller raised concerns regarding heavy vehicles gaining access to the development land via Well Lane and causing damage. *CB Cllr Bird* to raise with Highways.

Cllr Fisher reported that a request had been received to clear the footpath immediately to the West of St Nicholas following the recent hedge cutting. **CB Cllr Bird** to raise with Highways.
