[3] **THE MINUTES** of the previous meeting of 4th September 2017 which had been circulated, were confirmed and signed. **Prop GR Sec KF**

[4] MATTERS ARISING FROM THE MINUTES: (a) The VoG Council invited Councillors to attend a stakeholder consultation event at Pendovlan Village Hall on Tuesday 19th September at 10am to seek views and opinions for improvements to the M4 Junction 34 to A48 (Five Mile Lane) corridor including the Pendoylan corridor to access Cardiff Airport. Cllr Rawson attended the event, while Cllr Fuller attended the initial consultation on Thursday 7th September. Cllr Fuller felt that a decision had already been made on the preferred route as the title of the meeting was 'Junction 34 from the M4 access to the airport'. **(b)** Cllr Fuller has been unable to discuss with Cllr Bird which Housing Association has been allocated the affordable housing at the Redrow site, St. Nicholas. *Cllr Fuller to email Cllr Bird.* (c) Cllr Fuller and Cllr Fisher have arranged to meet on Wednesday 11th October to discuss proposals for the Strong Communities funding. *Cllr Fuller and Cllr Fisher to report back the Councillors at the November meeting.* (d) Following concerns raised by Cllr Grffiths regarding speeding traffic through Bonvilston and St, Nicholas, Cllr Bird had previously indicated that it could be something the S106 planning money could be used for. (e) Cllr Fuller confirmed that the Saturday traffic lights in St. Nicholas were present for the weekend following the September meeting, but have not been used since. Cllr Fuller advised that all utility companies completed their work at the same time and the temporary traffic lights will not be needed again. (f) Cllr Rawson is unsure if the hedge at Bonvilston Cottage has been cut back, following a letter sent the owners by the Clerk. *This has since been confirmed by* Cllr Rawson
