86/15 APOLOGIES FOR ABSENCE

87/15 DECLARATION OF INTERESTS

There were no new declarations of interest.

88/15 MINUTES OF THE LAST MEETING

The minutes of the meeting held on 7 October 2015 were approved.

89/15 MATTERS ARISING

All matters arising were on the Agenda.

90/15 ACTION PLAN UPDATE

Mr Dawson had sent his comments which were that in his view the Community Plan Group had fulfilled the original remit and most of the original issues had been dealt with and most of the outstanding issues came under the remit of the Parish Council. Mr Gregory explained that he had similar views except that key issues still remained including back lanes, broadband, development and the bi-pass. The majority of these require closer collaboration with the PC. The roll of the working group should develop possibly to provide additional support to the PC. After discussion it was

decided to leave decision on the future of the Community Plan Working Group until a decision on the Neighbourhood Plan had been made.

Speed Indicator Device (SID)

Still progressing.

OLD 40 MPH NOTICE

This has been notified to Cheshire East and they say that the only way to get rid of these signs permanently is resurfacing, however the Highways Department will see if there is anything that can be done in the meantime.

It was reported that the white lines at the junction had been completed.

Dog Fouling

Ms Kenwright asked that Cheshire East be asked for more stickers to be attached to waste bins in the Parish.

Proposed ByPass

No progress at this stage.

91/15 BROADBAND

The rollout of broadband in the area has been put back another 12 months. The Parish Council and Mr Gregory have a technical officer attending their meeting on 12 November to try and get clarification on the areas which will get broadband and the timescale involved.

92/15 PRESERVATION OF TREES IN AND AROUND CALVELEY

The map of the trees in Calveley subject to TPOs had been received. An officer from the Forestry Commission had contacted Cheshire East six months ago to try to get TPOs put on more trees in the area. This is ongoing.

93/15 CANAL AND RIVER TRUST

There is evidence that the area has been cleared and tidied. Ms Waterhouse will write to the Canal and River Trust for a timescale for the clearing of the rest of the area.

94/15 READING ROOM UPDATE

No progress at the moment.

95/15 ACCOUNTS

The Clerk had written to the External Auditors regarding their Issues arising from the Annual Accounts, in particular their comments relating to the Community Plan Working Group Accounts. They had sent an amended Issues document which addressed some of the complaints, but the Group thought that they should have gone further and also given an apology. This matter will be discussed at the Parish Council Meeting on 12 November.

In the meantime a cheque had been written to transfer the balance of the money from the Community Plan account, which will be closed once the account is empty.

96/15 NEIGHBOURHOOD PLAN

The Parish Council will discuss this at their meeting on 12 November and it was looking likely that they would arrange an Open Meeting at the School to assess the interest in the production of a Neighbourhood Plan.

Ms Greenway advised the meeting on the usage of the Website. After discussion it was decided to delete the Buy Sell page as it had not been used since the website was set up. The Group asked if details of Planning Applications in the Parish and surrounding areas could be included on the Parish Council page. The Clerk would arrange this.
