### **122/14    DECLARATION OF INTERESTS**

### **124/14    ACTION PLAN**

A meeting had been held between the Parish Council and the Community Group to look at joint interests and how the workload would be split. It was agreed that when the Action Plan is updated the updates would be written in

a different colour so that it is easy for residents to see what is being done without going through the whole Action Plan. The Working Group reviewed the Action Plan item by item and agreed the actions that are to be taken. These are included in the updated version of the Plan.

**125/14     A51 WEIGHT RESTRICTIONS**

Cheshire East Highways department are understood to be about to undertake work on Long Lane which might include the introduction of weight restrictions. It was pointed out that this will send HGV traffic past the School. Cheshire East is looking into this.

The 40MPH speed limit past the school is in place. It is hoped that this restriction will be amended to 30 mph in due course.

**126/14     NEIGHBOURHOOD PLAN**

There has been an approach from Cheshire East to produce a Neighbourhood Plan. A Neighbourhood Plan carries more legal weight than a Parish Plan and relates to housing and development. Mr Gregory said that he understands from his conversations with Cheshire East that the work that has been done for the Community Plan and the proposed Design Statement would make up a good percentage of the Neighbourhood Plan. Mr Gregory said he was awaiting additional information from Cheshire East which should clarify exactly how much additional work is entailed. A recommendation will then be sent to the Parish Council.

After discussion it was decided that a notice would be prepared and posted on the Parish notice boards explaining how to access the website in order to find out what is going on in the community.
