 - 6.1 By Councillor Rust Firrhill Health and Social Care Centre submitted in terms of Standing Order 28
 - "1) This Committee notes that:
 - a) at a meeting of the Health, Social Care and Housing Committee held on 11 December 2007 it was reported that NHS Lothian had been invited by the Scottish Government to support proposals for capital projects for funding from the Primary Care and Community Premises Modernisation Fund and given a provisional allocation of £3.49m; the Primary Care Premises Forum concluded that the priority project for submission to the Scottish Government would be the Firrhill Health and Social Care Centre;

- the Director of Health and Social Care was heard at said meeting in explanation of the plans for the Firrhill Centre and agreed to consider consultation and the relocation of GP surgeries and provide a list of future proposals for other local facilities;
- the said Health, Social Care and Housing Committee's decision was to (i) note the approved funding of £3.49m from the Scottish Government Primary Care and Community Premises Modernisation Fund towards the Firrhill Health and Social Care Centre; (ii) agree in principle to the location of the Health and Social Care staff from Oxgangs Social Work Centre and Victoria Street Social Work Centre; (iii) agree to receive a detailed business case in **March 2008**;
- d) at a meeting of the Pentlands Neighbourhood Partnership which took place in Oxgangs Neighbourhood Centre on **15 April 2008** Robert Aitken, Assistant Manager, Edinburgh Community Health Partnership, gave a presentation on a proposed integrated Health and Social Care facility to provide a range of NHS and Council services on one site in the Firrhill area; the intention was to improve services to the public by encouraging better joint working between the Council and NHS Lothian; details were provided as to the background to the proposals and examples of the range of services to be provided; the next steps in the process were outlined beginning with community consultation and the facility was scheduled to open in **2011**:
- e) on **15 September 2009** at a meeting of Pentlands Neighbourhood Partnership which took place in Fairmilehead Parish Church, Robert Aitken gave an update on the development of plans to provide an integrated Health and Social Care facility combining Council and NHS services on a site adjacent to Firrhill Medical Centre; approval of the business case by the Council and NHS Lothian was expected in early **2010** with a completion date in **mid-2012**;
- f) on 14 June 2010 a community meeting was held at Colinton Mains Community Education Centre noting a decision to centralise the three medical practices of Craiglockhart on Colinton Road, Firrhill on Colinton Mains Drive and Oxgangs Path surgeries at the new facility;
- g) on **10 June 2011** a public meeting, organised by Councillor Rust, attended by representatives from NHS Lothian, Monica Boyle, Head of Social Care Performance, City of Edinburgh Council, and ward councillors, was held in Pentland Community Centre at which a number of changes to the initial plans for the new facility were noted and undertakings were provided regarding public consultation;
- h) NHS Lothian confirmed by e-mail on **15 May 2012** to the Chair of Firrhill Community Council that they are continuing to await the Scottish Government to approve the medical centre project and that the project must now be "bundled" with Muirhouse and Blackburn which means that the business case will probably start in September;

2) This Committee therefore:

- a) laments the delays and uncertainty in this project over the past 5 years;
- b) regrets the lack of proactive engagement with the local community; and
- c) calls for the Convener of Health and Social Care and the Director of Health and Social Care to arrange for a report within one cycle updating the Committee and Colinton/Fairmilehead ward members on the current status of the Firrhill Health and Social Care Centre project, including clarification as to the roles and involvement of the Council and various partner agencies."
