Minute of the Annual General Meeting held on Monday 25 August 2014

### Presentation on "Diversity Day"

Sheila Watson, an art teacher at Firrhill High School, and school chaplain Gayle Taylor, gave a presentation to raise funds for a planned "Diversity Day" to be held in the school as a follow-up to previous events on the Holocaust and the Anne Frank's story. Its aim is to raise awareness in the school community of different groups of people who might experience negative stereotyping and bullying and show what can happen when prejudices go unchecked. By relating these issues to the Holocaust, I want to show the importance of that historic event to the education of our students and the lessons we can all learn from it today.

It is aimed at all S3 students at Firrhill High School but the school are also seeking to invite a wide variety of organisations and providers to the 'Day' which will be on Tuesday 18th November. The highlight will be the afternoon session when Harry Bibring will share his personal testimony of the holocaust.

The learning outcomes from this event will cover understanding, tolerance, empathy, inclusion and the harm caused by prejudice and discrimination. The underlying message for Diversity Day is that individuals should not be stigmatised for any reason whether it is their faith, culture, mental health or colour of their skin.

In addition to assistance from other members of staff and a small working group from S6, it is envisaged that representatives from the Anne Frank Trust; Anne Frank ambassadors, Anne Frank tour guides, Holocaust Educational Trust will also be involved. Firrhill HS are working in corporation with two other high schools to make it affordable to bring these representatives and Harry Bibring to Edinburgh to tell their stories but are still in need of funds or donations in kind to hold the event.

A discussion followed with a number of questions put to the presenters. The Community Council is not allowed to use its grant money for funding projects and thus is not able to give direct financial support but has access to other sources of funding and could assist in this task once a suitable financial plan for the event was drawn up.

## Ward Councillors' and MSP Reports:

### Councillors Aitken & Rust

Cockmylane: funding has been agreed between the Council's *Services for Communities and Parks and Greenspace Services* to enable this historic path to be upgraded.

Oxgangs Road North: the pavements between Redford Road and Colinton Mains Place are in the process of being resurfaced and new lighting standards installed.

**Action: EA to chase up on the identification of new recycling points for Firrhill area.**

### Councillor Richard Lewis

I received a couple of housing maintenance enquiries, which are being dealt with through the appropriate channels.

Enquiry received about a family of foxes being seen in gardens in The Gallilee. Looking to hear the Council views on this. Foxes are not classed as vermin, do not fall within the term of "pest" and are protected from cruelty by the Wildlife and Countryside Act 1981. They are not considered vectors of disease like rats or mice and do not cause structural damage. The Local Authority has no statutory obligation to control fox populations. Fox attacks are extremely rare with no confirmed cases having ever been confirmed in the Edinburgh area.

Planning enquiry/advice was requested in respect of a live application for a proposed Indian takeaway on Colinton Mains Drive. Application is currently pending consideration. Target date for decision is 5th September and this will be a delegated decision.

Had discussion with Mike Avery re funding options for a skate park at Colinton Mains Park.

## Minutes of Previous Meeting:

The draft minutes for meeting held on 28 July 2014 were reviewed. There being no corrections the minutes were moved for approval by SD, seconded by GD and agreed.

### Matters Arising:

#### **Oxgangs Path & ALDI Development**

Secretary received update from James Harbison on the progress of Aldi's plans for Oxgangs and reported that the missives are now concluded with City of Edinburgh Council - the missives with Church of Scotland were concluded some time ago.

The planning application is set to be lodged on Friday 29th August. This will show detailed plans for the store including the linkages with the library to the Broadway shops and the pedestrian route through the Aldi car park. A Traffic Impact Assessment to demonstrate that traffic associated with the Aldi store will have a minimal impact on the operation of the surrounding road network, will form part of the application.

The Company has offered to discuss any of the application detail, where we consider it necessary, otherwise hope to complete the application process before the end of the year.

In discussion it was stated that the monies raised from the sale of land to Aldi would be split 80% Church of Scotland and 20% to City of Edinburgh Council. Members did not think this could be correct as the council land seemed to occupy much more than 20% of the overall site. Councillor Rust agreed to make enquiries on this point.

## **Planning Application 14/02760/FUL**

This concerns the re-submission of a planning application applicable to No. 76 Colinton Mains Drive. Members advised that the matter is expected to go to the Planning Committee on the 5<sup>th</sup> September for a decision. The policy is that where a planning application attracts 6 or more comments a report goes to the Planning Committee.

A resident visitor advised that a neighbour had located a copy of the deeds for his/her property and it did include a clause restricting the use of any of the shop premises for the preparation of hot food. Visitor was advised by Councillors at our meeting that, even though the period for comments had closed, that such information could be sent in as it was factual information and not a comment.

In regard to concerns about alteration being carried out to the premises without a building warrant being applied for, members advised there were no outstanding warrants. Residents asked for assurances that the separating wall dividing the back and front shop and has since been demolished, was not a load-bearing wall. Cllr Rust to investigate.

## **Flooding at Colinton Mains Drive**

This relates to complaints about flooding in the area of the pedestrian crossing near its junction with Colinton Mains Terrace. The foundations of the houses in the immediate area suffer from constant dampness. Problem was caused by two drain pipes feeding into one of the same diameter but this was supposed to have been resolved by some of the works done for the flood prevention in the area. Cllr Aitken reported she has raised the matter to the appropriate department and it is currently under discussion. Will keep us informed of the discussions.

## **Police Report**

The Chair welcomed PC MacFarlane to our meeting and invited her to give a police report for the Oxgangs area. PC MacFarlane reported that during the period between 29<sup>th</sup> July and 25<sup>th</sup> August, they received 188 calls from the Firrhill/Oxgangs area. There were 28 calls regarding nuisance / loud music and neighbour disputes. There were also 13 domestic incidents. Below is a summary of more noteworthy crimes over the last four weeks:

### **Thefts or attempted thefts of motorcycles in area**

- 18<sup>th</sup> August – Oxgangs Drive – theft of OLP MV and power tools.

### **Vandalism**

- 17<sup>th</sup> August – Firrhill Crescent – a vehicle door was scratched
- 18<sup>th</sup> August – Oxgangs Drive – a vehicle front window was smashed

### **Housebreaking**

- 4<sup>th</sup> August – Colinton Mains Grove – 3 garden sheds were broken into – nothing stolen.
- 4<sup>th</sup> August – Colinton Mains Grove – garden shed broken into and bicycle stolen
- 8<sup>th</sup> August – Colinton Mains Grove – garden shed broken into and 2 bicycles stolen
- 9<sup>th</sup> August – Oxgangs Park – theft of bicycle from common stair storage
- 14<sup>th</sup> August – Colinton Mains Road – garden shed broken into and various items stolen.

- 5<sup>th</sup> August – Oxfangs Road North – fire-raising outside residential building
- 6<sup>th</sup> August – Firrhill Medical Centre – petty cash stolen from office

## Road Traffic Matters

Three reports regarding minor RTC (one involving a motorcycle striking a pedestrian. Motorcycle rider received a very minor injury.)

Several complaints were received regarding vehicles causing obstruction in the area. Generally these are inconsiderate and bad parking rather than actual obstructions.

## In discussion

It was noted that antisocial behaviour had increased in this area. A lot of residents in Oxfangs Gardens were complaining about noise. Noted that in an area where a skate park had been provided, the amount of ant-social behaviour had decreased.

## Domestic Abuse: Provision of Information

The community council asked for information to be provided on the level of domestic abuse in the area and is provided by the police. The term used in their report is 'domestic incidents' and we sought to have this defined. Confirmed the term does refer to reported incidents of domestic abuse.

In discussion it was noted that the police report itself does not highlight this information as only statistical information is provided, whereas the theft of a bike, for example, is recorded as a noteworthy crime. In view of the nature of such incidents, the police will not provide more detailed information. The community council, having requested the information, need to give thought as to how it can be used to increase its value.

#### **Colinton Mains Park: Skate Park**

Members agreed to adopt this as an objective of the Community Council as stated in the minutes of the previous meeting. See also under Councillor Lewis's report

#### **Oxgangs Gala**

Members agreed to adopt this as an objective of the Community Council as stated in the minutes of the previous meeting. Chair reported on the meetings she had attended, indicating there was a positive attitude by those attending to resurrect the Oxgangs Gala, to learn from previous mistakes and make it a fun day for the community. The Group meet on the 1<sup>st</sup> Thursday of each month..

Chair indicated the Group are looking at drawing up a constitution and asked that in the interim it be agreed they come under the umbrella of the Community Council for this year. Initial contact has been made to the local authority for permission to hold the Gala in Colinton Mains Park and they have advised that public liability insurance and a completed risk assessment form will be required for the event.

## South West Area Board: 14 August 2014

Report to Firrhill Community Council meeting held 25 August 2014.

The meeting was held Gate 55 which is a fairly new multi hub community venue. First time I have been in it and would have liked to have seen more. Previously a primary school, the building now facilitates a number of organisations. I imagine classrooms make an ideal size for many community meetings/activities whilst the sports hall would facilitate larger events, although I have to admit there was not much activity there on the 14th. Hopefully it is well used.

### NEP Presentations

Andy Wallace gave a slide presentation on the projects being carried out during this financial year giving the before and after scenes. I have to say that whilst all the areas were improved, it is meaningless if the work does not stand the test of time. Any neglected area will look better immediately after a make-over but that is not to say it will last. This was borne out by one of the other community representatives who spoke on the policy of replacing bin stores in the Wester Hailes tenements by street based collection points for waste and recycling. The mess that was once in a bin store is now out in the street.

The Ward 8 NEPs 2014/15 projects consist of:

#### **Project 1024: Oxgangs Crescent: footpath**

The footpath has been re-surfaced with asphalt and a pin kerb installed. The dilapidated fencing has been repaired.

#### **Project 1054: 2 Firrhill Drive: fencing**

New metal bow top fencing was installed which requires no maintenance. Still to be done.

#### **Project 1057: Oxgangs Brae: security lighting**

New security lighting to entrance door areas installed to improve safety and security of residents. Need to confirm if work has been carried out.

#### **Project 1061: 32-34 Oxgangs Avenue: drying area/gardens**

Footpath to the drying area re-laid and the drying area and gardens cut and cleared. Tenants now have improved access to their gardens and drying areas.

#### **Projects 1065/1066: Firrhill Drive: footpaths 18-20/26-28**

Concrete flags have been lifted and the footpaths resurfaced with asphalt along with new steps and handrails.

An issue came up re an email sent by Maureen Jarvis (OCRA) to the SWNO on concerns with project numbers – 1180; 1182; 1183. As all of these projects are in the Wester Hailes area I normally leave it for representatives of the areas concerned to comment. For two of the projects, Maureen expressed the view that weed killer and paint would be a better value for money. I have expressed the view in the past that the SWNO's aim is to tarmac over all areas that require some form of maintenance and that aim continues to be reiterated by Andrew Wallace every time he gives an update on the projects.

In regard to the third project, she expresses the view that as the area being improved is not exclusively used by council tenants there should be financial contributions from elsewhere, in this case – the general fund. I expressed concern that no effort was made to circulate Maureen's

comments to members of the Area Board despite the officers having received it the week previous. A reason was given but I frankly do not accept it.

It is a failing of these meetings that business papers are rarely issued in advance of the actual meeting. This results in members of the Board not having time to consider or consult on matters arising. The Area Board met infrequently and alternated its business between NEPs and Housing Management. The Board is now only meeting twice during this current financial year (14 Aug 2014 and 19 March 2015). Unless there is a change in format we may end up with each subject area being covered by an annual reporting. Changes are being introduced to the Partnership arrangements without any detailed documentation to support it. Unless the administration of the Partnership improves, community representatives will find themselves marginalised, only there for the purpose of giving credence to the idea of community participation.

Not all the blame can be laid at the door of the SWNO but it does not help if community groups do not receive full information or are given it at the meeting. The administrative support for the Pentlands Neighbourhood Partnership is minimal. Information that should be in the public domain, available through the PNP website, is not there. All that is available is the policy documents which express the objectives but not the results.

In regard to NEPs, I have raised concerns before about the value of some of the environment/improvement projects being carried out and proposed the Community Council be more proactive in identifying suitable projects. It was suggested this matter might fit into the 'Citizenship' part of Firrhill High School's 'curriculum of excellence' programme. Due to pressures and school holidays, action on this proposal was suspended, are we now in a better position to resurrect it?

### SW Outreach Project (SWOP)

Tracy Kelly, Project Worker gave a presentation this new initiative to assist social landlord and private tenants who are falling into rent arrears. The hand-out circulated with the agenda has been copied here for your information and I have posted the information on our website with a link to the relevant CEC webpage.

### **SWOP Welfare Benefit Advice Sessions**

The South West Outreach Project has been running since November 2013 and has provided welfare benefits advice to over 300 RSL tenants from the South West Edinburgh area. People attend the sessions for all sorts of reasons, from concern over housing benefit and rent arrears issues, to needing help with applying for a crisis grant or seeking advice on Personal Independence Payments.

The SWOP Project is being run by a partnership of agencies: Prospect Community Housing, the City of Edinburgh Council, CHAI and the Cyrenians. It has been funded by the Scottish Legal Aid Board through the Scottish Government's Making Advice Work fund. SWOP offers face to face welfare benefit advice for RSL tenants at local community venues in South West Edinburgh. The weekly sessions are at Clovenstone Community Centre, WHALE Arts Centre, Wester Hailes Health Agency, Wester Hailes Library, and Oxfangs Library. They are a mixture of drop in sessions and appointments provided by a full time advice worker. Approximately a third of those attending the sessions are Prospect tenants and two thirds CEC tenants. Tenants can be referred to the service by housing staff, voluntary sector partners and existing advice services. They can also self-refer.

### **A SWOP Success Story**

A lone parent with an older daughter in full time higher education and a dependent niece was referred by CEC due to the high level of her rent arrears (£1,489). She had no housing benefit in payment.

At the first appointment the client did not know what to pay to her rent arrears as she had a varying income. She was struggling both with the rent arrears and also with council tax debt. The advisor helped her to complete a housing benefit calculation, made an offer to rent arrears which was provisionally accepted by CEC, and gave her a form and information on setting up a standing order. Revenues and Benefits was also contacted and the client was advised on what information was required.

There was an identified housing benefit issue as the client's niece had not been included as a dependant, and there was also an incorrect non-dependant deduction for the client's daughter. The advisor submitted an appeal and the client was subsequently awarded £1,700 in underpayment of housing benefit and £70 in underpayment of Council Tax Reduction from June 2012. She also received an ongoing award of housing benefit.

Her rent arrears are now £200 and there is a payment arrangement in place which will clear the arrears in under one year.

### Local Community Plan – Update

This was a verbal report given by Scott Neil on the new format, with action groups replacing sub groups. Not clear what other matters are included but the proposals are going out for consultation. Seems more like the proposals are already in existence and we are being left with a fait accompli.

## Planning Report: August 2014

You will be aware from previous reports, the main topic for discussion within the planning arena has been the local development plan and in particular the allocation of land for housing. The housing needs and demand assessment figure, adopted by SESplan for the City of Edinburgh and the Lothians, continues to be a contentious issue with many community reps either disputing the figures or registering concern about the detrimental effect this will have. The impact of the increased figure demanded by the Scottish Government will see a consequential increase in greenfield/green belt sites being designated for housing. The fear is that brownfield sites will be left undeveloped as greenfield sites are seen to be more profitable for developers to build on.

Most of the activity this past month has come from the Edinburgh South West Communities Forum (SWCF). The Forum has kept us informed of their activities and I have attended a number of their meetings, the last one being on the 19th August.

I reported at the last meeting that the consultation period on the "Housing Needs and Demand Assessment" expired on the 1st August. Received a copy of the Forum's response to the consultation and have circulated it to all members for their perusal.

The Forum's draft policies on the Green Belt; Brownfield Sites and Coalescence were circulated for comment and /or amendment, prior to the meeting on the 19th where they were agreed and will be taken forward during future consultations.

At the Forum's meeting on the 19th an informative presentation on SESplan was given by Alice Miles, Lead Officer, SESplan. I am hoping to get a copy of the slide presentation and will make it available to members who wish a copy.

### Weekly Planning Bulletins

There was no planning activity in Firrhill Community Council's area. The only item of note is the following application concerning a new housing development in Fairmilehead CC's area.

11th August: Proposal of Application Notice concerning Morton Mains Conservation Area. Cala Management Limited submitted application 14/03149/PAN for a proposed residential development, comprising detached properties at land 105 metres east of 48 Frogston Road West, Edinburgh.
