# NEW SPORTS PAVILION

# At last work is well under way to building our new and improved sports pavilion in Colinton Mains Park.

In September 2009, the City of Edinburgh Council approved plans to create the new £1m facility, replacing the old pavilion on the site, which was no longer fit for purpose.

The Colinton Mains pavilion project is due for completion in early 2012. It was jointly funded by the Council ( $\pounds$ 670,000) and **sport**scotland ( $\pounds$ 330,000).

Councillor Deidre Brock, Sports Leader, said: "This Administration is fully committed to helping residents of all ages get involved in sport and stay active and our investment in pitches and pavilions is testament to that. Today is a key milestone in our ongoing programme of investment and I know the local community and sports clubs share our excitement about the development. New fit-for-purpose pitches and sports facilities will be integral to helping us fulfil our ambition of making Edinburgh the most physically active city in Europe by 2020."

The Council recently announced plans to invest £940k in pitches and pavilions over the next three years with 3G pitches at Meadowbank Sports Centre and Jack Kane Sports Centre at the top of the list. Brand new 3G pitches at Lochend Park and Meggetland were completed in 2010 and are both well-used.

Heather Levy, Chair of Firrhill Community Council, said: "This has been a very long time coming but thank God it's here now! The local community - especially the football teams of AC Oxgangs - are very excited about this new pavilion. It's almost the completion of all the upgrading work that's been going on at Colinton Mains Park, and it's part of the wider regeneration of the whole area." **Sport**scotland Chief Executive, Stewart Harris said: "The provision of a new pavilion at Colinton Mains Park will have an enormous impact on sport in the local community, complementing the work already carried out in providing new pitches. This exciting project will undoubtedly boost participation in the area, and I am delighted we have been able to provide design guidance and assistance, along with an award of £330,000 from our Sports Facilities Fund.

# Closure and Relocation of Barracks

#### What Impact will this have on our Community

**Residents** have you thought of the effect this will have on your area? The economic impact of the barracks closures on the local community would be immense. There are deep ties between the armed forces and surrounding communities. Apart from their comforting military presence the soldiers spend money in the local shops. During last year's heavy snow fall they cleared roads and paths and delivered supplies to the elderly and vulnerable local people. They also provided four wheel drive hospital transport.

Redford and Dreghorn barracks combined with Edinburgh castle put on the most spectacular 'International Military Tattoo' which brings tourists from all over the world swelling the coffers of the council and business in Edinburgh plus all around Scotland. Hopefully helping to keep council taxes in check! The three barracks, Dreghorn Infantry, Redford Infantry and Cavalry barracks, (IS THIS NOT ALREADY A SUPER BASE) all have the capability to accommodate, feed and provide laundry and drying out services for the hundreds of performers who practice and perfect their displays. There is also a good bus services 'when they are off duty' to visit the city for shopping etc generating more income for the city. Another advantage is the short journey to and from the castle.

On the down side if the barracks are sold and houses are built then our already stretched services would be rendered unfit for use such as medical, schools, sewage etc. How does selling off the barracks land at an estimated £50 million offset the costs of a super base in Kirknewton at a cost of £400 million as well as the waste of £24 million refurbishment of Dreghorn barracks

# **Firrhill Partnership Centre**

Work has begun on a business case for a **new health centre** incorporating Firrhill, Oxgangs and Craiglockhart medical practices. The NHS Lothian Capital Investment Group has backed plans to build the new £3.5 million Firrhill Medical Health & Social Care centre. As you are aware we and many others have lobbied hard to acquire a 21<sup>st</sup> century medical and social care services in this area. This is just the first of many processes that the project has to go through.

Firrhill Community Council would like to know your thoughts on this planned development.

#### Sports Pavilion.

This project will be another asset to the development of the 'Colinton Mains Community Sport Hub' as it gathers momentum over the coming months. Two of the key outcomes of the Hub, namely 'quality facilities' and 'improved access for local people' will be supported by this pavilion."

# Elaine Aitken on: Community Safety Sub Group

We all want to make our neighbourhood a safer and stronger place to live and improve the quality of life for our residents. To increase community safety, all sections of the community need to work together in partnership to create a safer environment in which to work, live and play. There are two groups which work closely together with local residents to make our area safer and provide a partnership approach to responding to local neighbourhood concerns and problems:

The **Community Safety Panel** which is funded by Lothian & Borders Police to enhance all aspects of community safety throughout the Pentlands area. Local councillors, Neighbourhood Watch co-ordinators and individuals who are interested in the local community meet four times a year to discuss and participate in initiatives for crime prevention, security for individuals and their homes and reduction of crime and fear of crime. The next meeting is on Wednesday 9<sup>th</sup> November at 7pm in Pentland Community Centre. If you are interested in becoming involved, please come and join us.

The **Pentland Community Safety Sub Group** of Pentlands Neighbourhood Partnership meets every three months at Oxgangs Neighbourhood Centre and is attended by local police officers, CEC community safety officials, environmental wardens and representatives of community councils, residents' associations and other local organisations.

The members set actions and three priorities for the area which become the focus of the Police Safer Neighbourhood Teams and Council Community Safety Teams for three months. These have included:

- Parking round schools
- Youth issues underage drinking
- Vandalism
- Pentland Hills inconsiderate camping, litter
- Increased level of crime by specific individuals and decisions made by bail hearings
- Dog fouling
- Anti social behaviour at St Johns Church and Oxgangs
  Drive
- Development of No Cold Calling Zones
- Fly tipping

The representative for Firrhill Community Council on the sub group is Alistair Hunter. The success of these groups depends on you! We need to hear about your concerns and issues so that we can discuss how they can be addressed. You can help us to make a difference here.

- · Improved communications and information between the Council and the public
- · Special arrangements for waste collection
- Investigating measures to prevent abandoned cars blocking roads
- · Improved identification and co-ordination of support to vulnerable people
- Increasing support for locally organised snow-clearing by volunteers

## **New Care Home**

People in Edinburgh will soon be able to take advantage of the latest innovations in residential and dementia care, as Care UK has announced plans for a new, luxury 90bedroom nursing home in the city's Colinton district. As well as expert care, the home will bring around 80 new jobs to the area, and an investment of nearly £10 million into the Scottish economy.

Work begins on the Redford Road site in September and the home is scheduled to open in spring 2013. The structure which currently stands on the site - an old Navy, Army and Air Force Institute (NAAFI) store - will be demolished.

#### **Braid Burn Flood Prevention Scheme**

This scheme seems to have caused as many problems as it has cured. When there is heavy rain too many people are finding the water gets trapped behind the flood wall and builds up back into their houses. During the last downpour, residents who thought their houses were protected by lift pumps suffered flooding because the electricity had still not been connected up to them almost a year after installation. If you are experiencing any new problem of flooding and you have not already alerted me to this please do so soon.

#### **Colinton Mains Park**

I was delighted to attend the opening last year, of the New Children's' Play Park, when local school children braved the weather to plant bulbs to mark the occasion. Unfortunately some of the equipment has broken and had to be removed as it had become a danger. It is taking longer than expected to replace this because the supplying company has gone out of business.

Meanwhile the new Pavilion which brings sports teams, six modern changing rooms with showers is progressing after what was a delayed start.

#### **Community Safety**

The new Police Inspector, Stevie Dolan is making his mark since his arrival less than six months ago. I asked him to take action against drug dealing and the spate of violent crimes which had injured some and left many youngsters afraid to go out. I am delighted that his firm action has produced results and in both these areas of crime.

Safety of our children around schools is now being tackled across the Ward. School Parent Councils and individual parents have raised their concerns about the dangerous behaviour of some drivers. Police are now attending at the start and finish of the day because some parents are not respecting that the zig zags are a no stopping zone for the safety of those on foot.

#### Bonfire Night - November 5<sup>th</sup>

The evening starts with children's entertainment from 6 o'clock, (this year there will be a £1 admission) bonfire lighting at 7 and fireworks from 7.30. **Pentland Community Centre** will as usual, be holding a firework display to rival Meadowbank but unlike there, it is not paid for by the Council and charge serious ticket prices. It is put on by the volunteers of the management committee (led by Dennis at the **Broadway Premier** shop) who want you to enjoy a bonfire and fireworks safely.

This year I have selected fireworks from the biggest wholesalers and can promise your kids and you a spectacular display lasting about 45 minutes. # Pentland Neighbourhood Partnership

Firrhill Community Council area including Colinton Mains and Oxgangs falls within the Pentlands Neighbourhood Partnership (NP) area. There are 12 NPs in Edinburgh, and they work to improve the quality of life in the area. Each NP is made up of a core **membership** including local Councillors and representatives from the Police, Fire, Health, the voluntary sector and the local community. The activities, membership and structures of NPs are guided by the issues that are important in the local area and I am the Convener of our NP in Pentlands and the Community Council is represented on the NP by Heather Levy.

NPs meet in public a few times a year, and any local resident can attend these meetings. Our NP includes all of the Colinton/Fairmilehead Ward and Pentland Hills Ward and so stretches from Buckstone to Ratho. As well as meeting in public, each NP develops **sub groups** to address local priority themes. Our sub-groups include health and employment, environment infrastructure and transport, community safety, funding panel and a process/business meeting. Please do pop along to a meeting!

NPs can make recommendations to the Council and other partner organisations about the way **services** may be delivered in the local area. They can comment on strategic decisions that affect the local area and offer funding opportunities and will play an important role working alongside the Community Council on matters such as any disposal of the army barracks.

The NP **Community Grants Fund** is a small grants scheme (provided by the Council) which can award small grants of up to £5,000 to constituted groups for local community activity that supports the work of the NPs and their Local Community Plans. Grants can be applied for throughout the year. Please get in touch for further information.

**Get On** is a partnership approach to enabling people to get help with everyday issues, so they can move towards better job or life prospects. You may recall when the unit was sited outside the Pentland Centre? It offers free information on help with volunteering, education, training and employment opportunities, as well as pointing people in the direction of support with issues of debt, housing, drug usage, mental health or other life issues. The service is person centered, so it is easy to access, and all staff in the *Get On* network are trained and approachable. Again, please contact me if you would like more information.
