1. Welcome, apologies and agree minutes

3. DCDH engagement with our three Councillors

JMcC had spoken to Robert Barr re attendance at meetings.

4. Progress Public Park development

SW reported that meetings had taken place with NA re establishing cost of traditional drainage replacement. Talks had also taken place re taking on lease or assets of park. Another meeting will be arranged to give advice on pros and cons of this initiative. Email was sent to Rob Fryer of Community Windpower regarding the cost of draining the public park and he replied that he was interested and would look to set up a meeting with DCSC and DPBT. This initiative is led by DCSC with support from DCDH.

5. Progress of sub groups

- a. Lynn Glen : Timber and metal work has been ordered. Trainees have now finished chain saw course so will be available in the near future. Meetings have taken place with Louise Kirk. Work should be finished by end May. Sub group is still awaiting bill for 2000 daffodils.
- b. Fairy Glen : Prices being sought for wild flower seeds – BD will help with this. These seeds to be scattered during Easter Egg hunt to be held on 13 April. DSC will be asked to supply marquee for this event. A BBQ will take place. Children will hunt for tickets which will then be exchanged for eggs. Fairy circles can now be seen. Primary schools have helped and may help in future in picnic area. The Christmas event was well attended. Bird boxes are/will be made. This sub group felt they could do with more members on the committee. They had volunteers willing to help but not be on committee. They now have 100 followers on Facebook. Paths and drainage working well. The Big Fit Walk was discussed. Date for this still to be confirmed. Funding for carvers has been applied for. (Venture Fund matched by



Land Fill). Money agreed by Venture Fund has still not been deposited. Garry Tait will chase this up. Details of carvers to be sent to Ruth so that they can be invited to next meeting Fairy Trail meeting. SW will do this.

c. Heritage Trail and Roadside Art:

Aug – paving installed.

Sept – film project completed and film shown in library

Oct – Heritage board erected

Nov – Heritage walk about (25 people attended). Park board complete (still to be agreed).

Next – further initiatives were discussed
