

DATA PROTECTION NOTICE

Privacy Policy & Statement Cole Street Methodist Church

1.0 Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation 2016/679.

2.0 Who are we?

Cole Street Methodist Church is the data controller (contact details at the end of this form). This means it decides how your personal data is processed and for what purposes. Cole Street is part of the Dudley & Netherton Circuit and the Wolverhampton & Shrewsbury District.

3.0 How do we process your personal data and keep it for?

Cole Street Methodist Church complies with its obligations under GDPR by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data. We use your personal data for the following purposes: -

3.0.1 by members of the Church, its Managing Trustees and the Church Council:

- 3.0.1.1 To provide pastoral care to the community, congregation, friends and family of the church;
- 3.0.1.2 To enable us to provide a voluntary service for the benefit of the public as specified in our mission statement;
- 3.0.1.3 To administer membership records;
- 3.0.1.4 To fundraise and promote the interests of the charity;
- 3.0.1.5 To manage our employees and volunteers;
- 3.0.1.6 To maintain our own accounts and records which includes safeguarding, medical, emergency requirements and the use of CCTV systems for the prevention of crime;
- 3.0.1.7 To inform individuals of news, events, activities or services running at Cole Street Methodist Church;
- 3.0.1.8 To manage the implementation of control measures relating to risk assessment;
- 3.0.1.9 To operate Cole Street Methodist Church's website and social media pages and deliver the services that individuals have requested.
- 3.0.1.10 To process gift aid applications.
- 3.0.1.11 To contact individuals via surveys to conduct research about their opinions of current services, fundraising etc. or of potential new services and fundraisers etc. that may be offered.
- 3.0.2 by the Managing Trustees & Ministers of the Circuit & the District:
 - 3.0.2.1 To administer membership records;
 - 3.0.2.2 To manage our employees and volunteers;
 - 3.0.2.3 To maintain our own accounts and records including but not exclusively Quinquennial, Quaterage & Circuit Governance;
 - 3.0.2.4 To operate the Dudley & Netherton Methodist Church website and deliver the services that individuals have requested.
 - 3.0.2.5 To inform individuals of news, events, activities or services running within the Circuit;

3.0.2.6 To share your contact details with the District office so they can keep records up to date and keep you informed about news, events, activities and services that will be occurring in the District and which are relevant to the role you are undertaking.

(Please note that these lists are not exhaustive and we may process personal data for other purposes, which will need to be notified and recorded. Remember, at the heart of this is ensuring that individuals are aware of exactly what we are going to do with your personal data and giving you the opportunity to consent where necessary).

4.0 What is the legal basis for processing your personal data?

We are legally able to do the above under the following Articles of the new GDPR:

Article 6

- We gain the explicit consent of the data subject (consent signed at the end of this form)
- Processing is necessary for compliance with a legal obligation in cases such as safeguarding where details may be legally required to be passed on;

Article 9

- We gain the explicit consent of the data subject (consent signed at the end of this form) to be able to tell people about events, news, services.
- Processing is carried out by a not-for-profit body with a political, philosophical, religious or trade union aim provided: -
 - the processing relates only to members or former members (or those who have regular contact with it in connection with those purposes); and there is no disclosure to a third party without consent.
- Processing is necessary for archiving purposes in the public interest, or scientific and historical research purposes or statistical purposes. (Please note however there is no obligation to provide your data for this purpose).

5.0 Sharing your personal data

Your personal data will be treated as strictly confidential, and will be shared only with those whom hold positions of responsibility within Cole Street Methodist Church and those in its voluntary employment or those whom hold positions of responsibility within the Dudley & Netherton Methodist Church Circuit and those in its employment under the control of the Methodist Church of Great Britain.

We will only share your data with third parties outside of the Church & Circuit with your consent.

6.0 How long do we keep your personal data?

We keep your personal data for no longer than reasonably necessary and we only retain your data for the purposes set out under section 3.0.1 and 3.0.2 and use criteria to determine how long to retain your personal data such as: -

- in case of any legal claims/complaints;
- o for safeguarding purposes etc.;
- for historical & statistical purposes;

7.0 Your rights and your personal data

Unless subject to an exemption [under the GDPR], you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which Cole Street Methodist Church holds about you;
- The right to request that Cole Street Methodist Church corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for Cole Street Methodist Church to retain such data;

- The right to withdraw your consent to the processing at any time;
- The right to request that Cole Street Methodist Church provide the data subject with his/her personal data and where possible, to transmit that data directly to another data controller, (known as the right to data portability) in cases such as medical treatment, membership transfer etc.;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data for the purposes of scientific/historical research and statistics;
- The right to lodge a complaint with the Information Commissioners Office (ICO).

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
