4. Public Forum

Pot Holes Grange Lane

Resolved to approve the Parish Meeting minutes held on 13 June 2019. The Minutes were signed by the Chair.

6. To receive County/District Councillor Reports

Councillor Tittley provided an update from Staffordshire County Council.

He reported that works on HS2 continued in a chaotic fashion creating a lot of work for the County.

He reported that SCC were targeting their limited funds at protecting vulnerable people and that this meant other work undertaken by the Council was being impacted upon. He said the financial environment was very difficult.

7. Police Report

The local Police Officer and Police and Community Support Officer attended the meeting and provided details of local policing issues.

It was noted that the policing areas did not match Parish Boundaries and that the figures covered North Lichfield which distorted the picture of Crime in the Parish. The officers took the opportunity to advise Parishioners to ensure doors and windows were locked at night and if they were in the back garden during hot weather, to advise that keyless entry keys were stored in faraday bags and to inform residents of Lichfield District Council (LDC) funding for heating installation for older people.

Councillors reported several issues of concern including:

- Cars meeting for suspected drugs related issues at Goosemoor Green, Chorley
- Dark Astra driving recklessly at 10.30 in Elmhurst
- Cannabis Farm detritus Farewell

Noted with thanks. Councillors requested further Police updates to future meetings.

8. Parish Lengthsmen/women

The Chair reported that the County Council had indicated that Parish Council's would have to take on more tasks in future regarding upkeep of the local area. He suggested that the Council may wish to look at appointing a Lengthsman/woman – essentially a caretaker for the Parish to undertake small jobs like grass cutting, repairs etc. He reported that Shenstone had adopted this approach.

Resolved to ask the Clerk to circulate the research provided by the Chair.

9. Meeting regarding A515 turning restrictions

The Chair reported that a meeting had taken place between SCC Highways, National Farmers Union (NFU) and Local Councillors to discuss the problems created by the turning restrictions on the A515. Farmers had been asked to provide detailed feedback on the problem to provide evidence for an exemption. It was hoped that a speedy resolution to the problem could be found as harvest would soon be underway.
