Last week the Government published the **Lawton Report** 'Making Space for Nature: A review of England's Wildlife Sites and Ecological Network'. The report is an independent review of England's wildlife sites and the connections between them, with recommendations to help achieve a healthy natural environment that will allow plants and animals to thrive. Led by Professor Sir John Lawton, the review was set up to look at our wildlife sites and whether they are capable of responding and adapting to the growing challenges of climate change and other demands on our land. Next month officials from 192 countries and the European Union will gather at Nagoya in Japan to agree how to tackle biodiversity loss. They will set new targets for the conservation and sustainable use of biodiversity for the next ten years, and develop a vision for 2050. This is the tenth meeting of the Conference of the Parties to the **Convention on Biological Diversity** (COP10). Ahead of COP10, the **Natural History Museum** has launched a project called '**The Big Nature Debate**' to get the public talking about biodiversity and the world around them. The debate is a platform for information, opinion and discussion about biodiversity. By visiting www.nhm.ac.uk/bignaturedebate people are able to quiz biodiversity experts, debate issues in forums, get updates with the latest biodiversity news through the Museum's Facebook page or by following the Museum on Twitter. The site hosts thought-provoking blogs from biodiversity experts and other key thinkers on subjects such as 'what the world might look like in 2050' or 'has biodiversity loss reached a crisis point'.

Warwickshire Wildlife Trust has been awarded funding through the Vision for Stour Group of Stratford-on-Avon District Council to carry out surveying and habitat improvements for water voles (*Arvicola amphibius*) on the River Stour and its tributaries. Numbers of this UK and LBAP priority species have declined by as much as 95% in the UK in recent years, and surveys in Warwickshire reflect this devastating trend. The Trust has teamed up with the newly-formed Stour Valley Wildlife Action Group to carry out surveying for water voles, otter and mink during September at over forty different locations throughout the Shipston-on-Stour area. Once this surveying has been completed, the next stage of the project will be to protect any water vole populations identified and improve riverside habitat to encourage the revival of this charismatic riverside mammal. A new non-native and invasive species of freshwater shrimp has recently been recorded at Grafham Water, Cambridgeshire. *Dikerogammarus villosus* (known as the 'Killer shrimp') was found at the site by anglers on 3rd September. This is the first record of this species in Great Britain. It is native to the Black Sea and the Caspian Sea. It is already present elsewhere in western Europe and in some areas, e.g. at sites in the Netherlands, it has eliminated native shrimp species. It also predates other freshwater species, including mayflies, damselfly larvae and small fish.
