This is probably the most positive newsletter so far! We have passed so many milestones and the reality of our own workshop really seems to be in sight at last.

Thanks to Gerry's persistence we have had our grant application from Veolia Environmental Trust approved, to the tune of over £30,000, which covers the cost of the building. We have received the long-awaited documents from Wessex Synod Trust permitting us to make the hole in the wall and install our gates, and to lay the base. And we are almost there with Havant Borough Council Building Control's final approval of the technical plans. At the time of writing we have begun installing the gates, and are getting quotes for the groundworks and laying the base and for erecting the building.




We have just received our final payment from Co-op, taking the total to an amazing £1404, so thank you to everyone who nominated HIMSA as their chosen charity. Our thanks to the local store for laying on the celebration event on 24 November. Nationally, the Co-op donated an impressive £19 million for local charities this year.

Total income in 2018 was £12,478.

Major items of expenditure included £2,363 on the new building, £912 on insurance and tax for the van, £512 on room hire, £310 on shirts stock, and £117 on materials for the bench renovation project.

Income exceeded expenses by £7,630. For 2019 the figures will look very different!
