Kirkwells Presentation. MS Louise Kirkup (Kirkwells) gave the meeting an overview and this was followed by an
15/02 open discussion on various aspects of the Neighbourhood Plan and the potential benefits of using the
professional guidance available from Kirkwells– a company with considerable experience on the
subject of Neighbourhood Plans. The Chairman thanked Ms Kirkup for her attendance and the
Parish Council meeting then started.(non PC members of the Steering Group then left).

15/04 a. It was agreed that Kirkwells assistance in the forming of the Neighbourhood Plan should be pursued.

Planning: Planning Application P150008/CU Proposed Prior Approval of Change of use of an agricultural

Finance: a. The agreed Precept for 2015/16 for £7,000 had been submitted.

get proof of identity from all PC members to finalise the process of obtaining the Title Deeds for the
Cook's Charity field and was given a cheque for £40.00 to pay the Land Registry Fee.
