- 9.b. Illegal Off-roading Group As per police report, there had been a recent successful operation. Cllr Rutherford to act as PC representative. No further updates.
- 9.c. SL District Association next meeting is 9<sup>th</sup> June.
- 9.d. High Furness LAP next meeting is either 8<sup>th</sup> or 15<sup>th</sup> June (TBC).
- 9.e. Coniston Water Association no updates
- **10) Updates for Ongoing Issues**, actions from the last meeting not covered elsewhere on the Agenda and items for the agenda of the next meeting:
- 10.a. X112 Bus Service Cllr Hall advised there is a new timetable from today and of the new service once a week from Barrow-Coniston-Skelwith Bridge-Ambleside. The Friends of X112 have received a grant from the Rawdon Smith Trust. The bus service is still quite vulnerable. Fuel costs = approximately £100 per day per bus. The nos of passengers by June will be 50,000. Links with Barrow are successful and there is going to be a specific fund raising group.
- 10.b. Superfast Broadband cabinet 2 is now live at Lowick Bridge. No developments known. Cllr Jones to contact Mike Postle.
- 10.c. Community Plan no developments. Cllr Hall explained that a community plan gives the planning authority a greater opportunity to respond in a manner to suit the parish needs. A community plan can be comprehensive or small.
- 10.d. Kirkby Moor Wind Farm RWE's application to extend the lives of the 2 masts was rejected and should be removed by the end of May. There has been no appeal about the wind farm application deadline to appeal is the end of May.
- 10.e. Blea Brows sale sale to RST complete. **Resolved:** To remove from Agenda.

10.f. NuGen & North West Coast Connections Project – Cllr Rutherford attended the NuGen displays. The Stage 2 manned consultations are on: 14<sup>th</sup> June (Askam); 15<sup>th</sup> June (Barrow); 16<sup>th</sup> June (Broughton) – all 11.00 am – 7.30 pm. Cllr Rutherford advised it is good to go with questions prepared. She will circulate questions for the consultation events. The application will b submitted in April 2017 with a planned decision in 2018. Cllr Rutherford questioned them on roads in South Lakeland; the harbor; fracking & the rail line. She advised that the maps are unclear of the Cumbria coastal way.

Vera Grant asked if it was still PC policy to oppose the overhead wires. This was confirmed. Cllr Hall advised that the Chairman of LDNP & officers are regularly attending the NuGen meetings.

10.g. Highways – Cllr Fox reported that the U5081 repairs are of good quality. Resurfacing is about to take place on the A5092. The patching on the side of the road at Water Yeat has been done

10.i Tanglewood Caravan – A reply had been received from LDNP. Cllr Jones gave a summary of the communications to date. No further action resolved.

10.j Crake Valley Caravan Park – No further updates from LDNP. Members of the public at the meeting expressed concern re walls coming down that overlook the drop to Lake Bank and should fences be erected, they will be on their land. Cllr Sanderson suggested they write to the owner of the caravan park and copy to the PC.

**Resolved:** On receipt of copy letter, Clerk will then also write to LDNP about this, copying in relevant parties. The Commoners wrote to Mr Khan on 30/3 but havn't had a reply. Cllr Rutherford to forward photos to the Clerk.

Cllr Sanderson suggested that the most recent reply from LDNP seemed to imply that planning issues are separate from planning inspectorate/secretary of state approval. Cllr Hall advised that a meeting tomorrow with LDNP is taking place in order for all connections to be made within the organisation.
