- b) A training session on Standards has been arranged for Parish Councillors. The training will take place on Wednesday 6 July 2016 at 5.30 pm in the Council Offices, Crescent Gardens, Harrogate HG1 2SG. - 7) Complaint regarding agricultural traffic at night Councillors feels we are a rural community and appreciate that farmers have a tight window to work when the weather permits.

- 8) Pinfold tenancy/new lease Mr Johnson -request for five year tenancy not just three. Councillors happy to offer five year tenancy and Councillor Hurford signed his part of the tenancy form. Pinfold is well cared for Authorisation of expenditure for crushed stone in entrance way and authorisation for gate refurbishment one large bag would be £40.80 including vat all in favour of buying this. DTMS quote £275 plus vat Councillors would like a second quote and suggest asking Tower Hill at Mickley for one
- 9) Councillors discuss and make decision on whether to continue meeting every two months or to go back to monthly meetings Councillors majority want to refer back to monthly. Decision was made to refer to monthly meetings from the August meeting
