2. Declarations of interest

5. Progress reports:

 - b) Coventry Gateway Project: to note a public enquiry is underway, beginning on the 8th April, expected to last 16 days and be completed by May 13th.

6. HS2: to consider the following motions with respect to the HS2 Hybrid Bill:
 - a) that Weston under Wetherley Parish Council judges it expedient for the Council to oppose the High Speed Rail (London-West Midlands) Bill
 - b) that Sharpe Pritchard (Parliamentary Agents) be authorised to sign and present the Petition of the Council against the Bill
