# HS2 Bulletin

High Speed Two (HS2) is the Government's proposal for a high speed north-south railway. The proposal is being taken forward by HS2 Ltd in two phases:

**Phase One** will connect London with Birmingham and the West Midlands

Phase Two A will connect Birmingham and Crewe

**Phase Two B** will finish the route to Manchester and Leeds

The focus of Warwickshire County Council's role on HS2 is to scrutinise the implications of the scheme and develop protection and mitigation for communities around planning, highways, traffic and transport, public rights of way, historic environment, and ecology.

# The Select Committee publish HS2 report

The House of Lords HS2 Select Committee published its findings after sitting for more than 60 days and hearing 314 petitions since May. Warwickshire County Council presented its fourth petition to Parliament in July on unresolved issues including local authority costs and ecology.

In the report, the Lords main recommendations are to remove Clause 48 of the HS2 Bill giving wider powers to HS2 Ltd to compulsory purchase land deemed as "undesirable and unnecessary", and for HS2 to treat urban areas the same as rural settings in compensation terms.

Following the publication of the Lords report, the HS2 Hybrid Bill can proceed to the next stage. The Department for Transport and HS2 Ltd will issue a formal reply to the report, and the Bill will go to the House of Lords for its third reading. After consideration of amendments the Bill will receive Royal Assent and will become the legislation needed for the railway to be built. Work is expected to start this year.

The committee report marks the conclusion of the Select Committee's work. Royal Assent is scheduled for February.

### Parliamentary reception promotes West Midlands connectivity

The West Midlands Combined Authority (WMCA) hosted a reception in the House of Commons to highlight the positive impact of HS2 on the region.

Speakers at the reception, titled 'HS2 at the Heart of West Midlands Connectivity', included Transport Secretary Chris Grayling and WMCA chair Cllr Bob Sleigh, who explained how the authority was determined to maximise the benefits offered by HS2.

The WMCA's 'HS2 Growth Strategy' features a range of infrastructure projects and investment that builds on the high speed rail line's potential for growth and includes:

- Metro tram extensions and other transport schemes to connect more than two million West Midland people to HS2.
- The creation of 2,000 HS2-related apprenticeships.
- Support for hundreds of businesses looking to take advantage of the opportunities created by HS2.

HS2 Ltd has established its headquarters in Birmingham city centre, employing 1,300 people and the National College for High Speed Rail is due to open in Birmingham next year. An investment is also being secured as part of the £1bn Curzon Masterplan centred on land around the HS2 station in the city's Eastside district, and for the UK Central development at the Interchange Station close to the National Exhibition Centre and Birmingham Airport.
