6.1 Finance - JD Treasurer's report – 10th May 2018

The accounts for last year have now been reconciled, and a printed copy will be put on the notice board (if not there by the meeting). Only a few omissions, income has increased by £215.80 over the draft set and expenditure by about £360. Some of the money might move between items slightly in the final (audited) account.

As at Wednesday evening the club financial assets were £33,750, slightly down from the state last year (£35,117) in the main due to a reduction in the money received from renewals, for which the increase has not compensated completely. A mixed set of reasons for non renewal, from being too old to preferring to spend the money on chasing a little white ball around (not understood by the Treasurer) but in part possibly triggered by assessing the increase against the value they got out of it?

We are currently 'in debt' to the company that replaced Southern Water (who had given up responsibility) for 14 month's supply. They are taking their time in correcting the bill from £1,800 to approx. £700 (They had the charge return to sewers at 95% instead of 21%).

Having arranged for the supply of Makro cards following the last meeting, these have been supplied and delivered to the nominated persons. Unfortunately, on first use on Friday, it was rejected as a method of payment by the till operator, making all the cards pointless. A complaint has been lodged.
