## SPECIFIC PARENTAL PREMISSION IS NEEDED BEFORE A YOUNG PERSON CAN TAKE PART IN A SHOOTING ACTIVITY

- Using .177 Air Weapons and Ranges built to the National Small-Bore Rifle Association Guidelines. Shooting
  is one of the activities available to participants.
- Leaders undertaking instruction in this activity have qualified for the Tutors Diploma under the National Small-Bore Rifle Association Youth Proficiency Scheme.
- **Targets showing either humanoid or animal shapes will NOT be permitted**. (This requirement also relates to Archery but specific Parental Authority is not required at this time)

#### This authority is specific to Shooting Activities within Sheringham & Beeston Regis Activities Programme

S.21 Firearms Act 1968 Prohibits possession of firearms or ammunition (under any circumstances), by persons convicted of crime and sentenced to a term of imprisonment (or young persons equivalent) of 3 months or more. The Act also applies to Airguns.

### Extracts from 'Section 21' Firearms Act 1968

- 1. A person who has been sentenced (to custody for life or) to preventative detention, or to imprisonment or to corrective training for a term of three years of more (or to youth custody (or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a term in a young offenders institution in Scotland, shall not at any time have a firearm or ammunition in his possession.
- 2. A person who has been sentenced ... to imprisonment for a term of three months or more but less than three years (or to youth custody ( or detention in a young offender institution) for such a term), or who has been sentenced to be detained for such a tern in a young offenders institution in Scotland, shall not at any time before the expiry of the period of five year from the date of his release have a firearm or ammunition in his possession.

#### This means:

- Section 21 prohibits the possession of a firearm and ammunition (under any circumstances), by a person who had been convicted of a crime and sentenced to a term of imprisonment (or its equivalent for young persons) of 3 months or more. The prohibition applies in all circumstances, including handling and firing at an approved shooting club or clay pigeon shoot where a certificate is not ordinarily required. It also applies to the possession or use of other categories of firearms and ammunition such as AIRGUNS or shot cartridges for which a certificate is not needed.
- A sentence of 3 months to 3 years attracts a 5-year prohibition, shorter ones no prohibition but a longer one means a live ban
