MINUTES OF MEETING OF TILlicoultry COMMUNITY COUNCIL HELD IN THE COMMUNITY CENTRE, TILlicoultry ON 8TH NOVEMBER 2011 AT 7.30 P.M.

CHAIRPERSON'S REMARKS

All were welcomed to the meeting and hoped that had a good time on Guy Fawkes night.

MINUTES OF LAST MEETING

Shirley said that PC Cuthbertson's first name was Jordan and not George. Acceptance of the Minutes of the meeting on 13th September thus amended was proposed by Elma Mitchell and seconded by Melanie White. There being no dissent, the Minutes were accepted as a correct record.

TWINNING

There was no update for this meeting. Ian Gordon had not yet e-mailed the Dollar Twinning Secretary. It was agreed that Ian Gordon should contact Eddie Inglis about where we all were. This will be on the agenda for the next meeting.

POLICE REPORT/PACT

Jordan Cuthbertson was on a course and could not attend.

The detection rate for this month was 59% and included theft, vandalism, etc. The person who attacked a green on Tillicoultry Golf Course had been detected.

There had been high visibility foot patrols to deter shoplifting and vandalism.

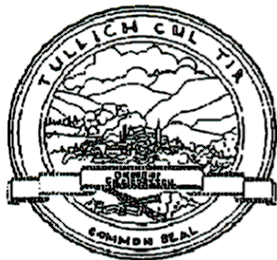
There were some tickets available for the OAP Christmas party in Alloa Town Hall.

There had been persons playing football in Murray Square and Shirley said that some of them had been moved on from time to time.

The relocation of the Police Office was under consideration but there was no decision so far. Shirley said that the office would only move when another location was identified and various locations were being considered.

It would seem that shoplifting at Sterling Mills is on the increase and becoming a problem.

There are 4 Community Wardens in Clackmannanshire and they are very thin on the ground and they are rarely in Tillicoultry.

The comments on parking cars at the layby at the Royal Hotel was discussed again. At least one licence of the vehicles concerned had expired at the end of October and could be illegal because it had not been renewed. If it was licenced it was still an offence to not show it on the vehicle. It was pointed out that a licence was required to sell vehicles on the street.

COUNCILLOR'S REPORT

John Biggam said that the speed bumps in Stalker Avenue and Walker Terrace had been checked and were now sorted.

The problems with the loose bits on the footbridge in Mill Street have been noted and they will be repaired.

Clackmannanshire Council has no budget for Twinning. John will ask the question about allowing the twinning to proceed at no cost to the Council and report back within 14 days. If this does not happen Ian Gordon will remind him.

Alva Pool has been saved at least for the near future and Tillicoultry CC wishes the Ochil Leisure Enterprise every success in re-opening the Alva Pool as soon as possible.

John said that Clackmannanshire Council has gone the road of invest and save. No one could understand this concept.

Clackmannanshire Council would appear to have saved some £6.4m so far this financial year. They wish to save £8m in the fiscal year until 31/03/12. It was not clear what services had been cut to make this saving. It may be "Pie in the sky".

The electric heating in council houses will be replaced with gas CH as long the tenants are willing to go along with it. This seems to be a "suck it and see" exercise.

There would be a car park on the old Health Centre for at least 2 years. There followed a discussion on car parking in Alloa.

The question of overgrown trees on Dollar Road was raised. The trees concerned were obstructing the footpath on the north side of the road. John Biggam will enquire about this problem.

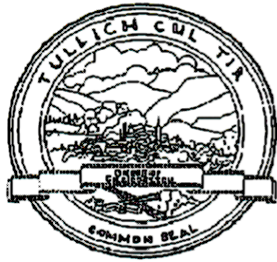
There should be a decision on 17/11/11 about the Marchglen problem. The meeting is at 10.30 am in the Chamber in Greenfield.

PLANNING REPORT

There was nothing to concern the Community Council in the last month. Billy Shepherd was given the Planning Reports from Clackmannanshire Council for the last month to check this out.

SOCIAL COMMITTEE

The last Gala meeting was attended by only three Community Councillors and was not quorate and could not make any decisions.

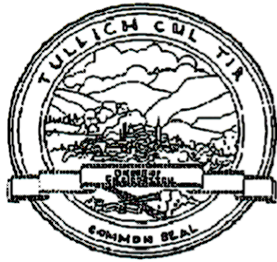
Ian said that the main act would be the same as last year and that this Gala had no requirement to pay for travelling or overnight stay. This would reduce the cost by around £300.

The lights are proposed for 2012 and any grant from the Windmill Fund will be conditional on the Council's agreement to pay for the electricity and having the lights on their lamp posts etc.

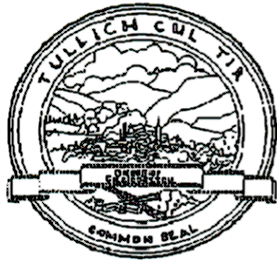
