# 2.b. East Tisted Superfast Broadband update

## An email from Phil Cutts for ETSBC on 25 October 2015:

"On behalf of East Tisted Broadband Campaign I'm very pleased to tell you that Superfast Broadband is coming to our village and that the service should be available from the end of November.

I can also advise you that we will not now be looking for additional financial support and would like to thank you for your encouragement for this important project."

#### A communication sent out to the village on 3 November 2015:

East Tisted Broadband Campaign on behalf of Rotherfield Utilities Ltd is pleased to announce that Superfast Broadband is coming to East Tisted Village. The current estimated timescale for the upgraded hardware to be installed is the end of November 2015. Any voluntary contributions from owner occupiers would be welcome when the upgraded service is available. This is most likely to be in the middle of December. Unfortunately BT Openreach have not be able to provide a copy of the estimated speed tables shown at the village presentation on 10<sup>th</sup> September. Please remember that once the new service is live you can benefit from that with any internet service provider (ISP) that provides high speed broadband Fibre to the Cabinet(FTTC). See

	(Amery Hill and Eggars) students through the village, but this does not serve Alton College.

	We do not use any services as no services attend the village although we are aware of

Having raised this issue at our Parish Council meeting on 10 September, it is apparent that there is some demand for public transport, particularly for families with teenage children wanting to get to Alton, Petersfield, Winchester etc. Any service with routes that include stops on the A32 would be welcomed as rural communities should not be marginalised with the assumption that 'everyone drives'. Without proper public transport, the danger is that villages become unattractive places to live for families. Many thanks for the opportunity to comment, perhaps it would be possible for a public consultation to be made in the future.

# 5.c. EHDC calls for Farnborough TAG flight path plans to be scrapped or the public consultation re-run

East Hampshire District Council has called on the Civil Aviation Authority to either reject plans to alter flight paths around Farnborough airport or re-run the public consultation.

The council says the proposed changes, submitted by TAG Farnborough, would cause noise, pollution and have a damaging impact on the local economy. It also believes a new consultation should be held after flaws with the original attempt, including a fault on TAG Farnborough's website leading to many representations being lost.

TAG Farnborough has applied to the Civil Aviation Authority (CAA) to increase its airspace in order to make the airport more efficient. However, EHDC has written to the authority strongly opposing the plans, saying it would have a 'serious impact on residents and businesses'. The current proposals envisage a massive increase in impact on East Hampshire settlements from increased overflying.

More flights, at lower altitudes, will also have a detrimental impact on the district's beautiful countryside - over half the district is in the South Downs National Park – and that will affect tourism and wildlife. Tranquillity is a highly attractive feature for visitors to the area and a network of businesses, including hotels and pubs depend on that trade.

The proposal to restrict the airspace available to the Lasham Gliding Society and other users of Lasham Airport and the consequent impacts on supply chains, risks local jobs. EHDC is also concerned that TAG's consultation was interrupted by a website fault and that the responses made by local residents and businesses over five days, at a critical time in the consultation, have been lost. It also points out that the airspace proposal submitted to the CAA is considerably different to the consultation proposals and includes changes to proposed routes, on which the community and local authorities have not been consulted.

Cllr Ferris Cowper, EHDC Leader, said: "East Hampshire District Council is strongly opposed to the proposed flight path changes because of the serious adverse impact on residents and businesses. We are also very concerned that the appropriate processes were not followed during the consultation. We are urging the Civil Aviation Authority to either reject the application or defer their consideration to allow a proper consultation to take place."

I estimate that 2015/16 annual expenditure will be £3,736. In accordance with our financial regulations, we are required to keep a six month contingency which calculates to £1,868. As you can see, the estimated closing bank balance at the end of this financial year is projected to be £3,115, so we are relatively healthy and could considered reducing the precept accordingly. However, I would recommend caution one two counts; firstly, once the request is reduced, it may be difficult to raise again it in the future should a special project arise; and secondly, with the devolution of powers to Parish Councils becoming more prevalent, expenditure may rise as the Parish Council is required to undertake extra responsibilities. This is a difficult situation to predict in terms of the finances and I would therefore recommend a static precept request of £3,500 for the 2016/17 financial year.



# 7.d. Ground Maintenance Contract

To whom it may concern

#### EAST TISTED PARISH COUNCIL

#### GROUND MAINTENANCE FOR THE 3 YEARS - 2016 2017 2018

East Tisted Parish Council is responsible for two areas of ground within the village, the pond and the playground area off the A32. Using the specification below, you are invited to provide a tender quotation for the maintenance work to be carried out in the three years from 2016 trough to 2018. This will be considered at East Tisted Parish Council meeting to be held in February 2016 and you will be notified then if you have been successful.

#### **General**

The work is required to be undertaken every two weeks during the period from Lady Day (25 March) through to Michaelmas (29 September) in each year.

Provide the appropriate equipment and fuel for the job.

Remove all cuttings/debris.

Provide evidence of adequate public liability insurance.

#### Pond Area

The ongoing, regular work required is to mow and edge the lawn surrounding the pond leaving a one metre 'wildlife belt' to the inside slope. Strim around the trees and ensure a generally tidy appearance.

Any extra work to clear and strim the 'wildlife belt' and trim the trees will be requested individually.

#### **Playground Area**

The ongoing, regular work is to mow and strim the area surrounding the playground equipment on the left hand edge of the cricket pitch up to a 10 feet boundary of the equipment.
