Parish Chairman Barry Davolls Reports Back

Lengthsman

Our lengthsman, David Ogilvie, has now served his notice and has moved on to pastures new. A final thankyou to David for all his hard work over many years helping to keep our village in good shape. The South Petherton-based lengthsman scheme has now ceased to exist with the six parish members (including Lopen) making their own arrangements going forward. Lopen has yet to officially engage a replacement for David but has provisionally agreed to contract the District Council run Parish Ranger scheme in due course. An early September meeting and tour of the village has been arranged with a view to agreeing the scope of the work required and finalising the terms of the contract.

A repayment of surplus funds left in the South Petherton scheme has now been agreed and Lopen's share will be paid out during September. As it stands, there has been no village maintenance since August 1st and this will remain the case until the end of September. If any critical or urgent matter arises it will be dealt with either by a one off contract and/or volunteer help as required. Please bear with us during this changeover period during which a normal service cannot be maintained.

Lopen's Lorry Weight Limit



I have now obtained a copy of the weight restriction order relating to Lopen which covers Holloway for its entire length from the Lopen Head roundabout and extends to 150 metres south of Mill Lane on the Merriott road. The restriction applies to any vehicle in excess of 7.5 tonnes maximum gross weight except for deliveries and collections on or adjacent to the restricted road, or where a location is only from the restricted road.

In brief, the weight restriction applies to all vehicles except for buses, emergency vehicles, those relating to the provision and maintenance of the utility services and for construction and highway maintenance.

A recent local planning application identified Holloway as the main route for delivery to the site. The proposal would have led to increased movements through the heart of our village of large vehicles well in excess of the 7.5 tonne limit. To our surprise and disappointment the County Council Highways team did not object to the planning application and the Parish Council had to intervene to encourage an alternative route to preserve the hard fought for weight restriction in Lopen. As it stands, the developer has now re-routed accordingly but we will keep a close eye on matters as they progress.

Dog Fouling (*again*)

I am sorry to say that the Parish Council is receiving an increasing number of complaints regarding fouling of roads, fields and footpaths across the village. This is not an isolated issue for Lopen but one that many councils are facing. Some local authorities are going to extraordinary lengths to catch offenders in an attempt to stamp out this unhealthy and antisocial behaviour.

I doubt if 'poo boxes', which at one point were freely available but which are now very expensive, would solve the problem as the vast majority of fouling is left 'at point of lay'. There have been some instances where the 'poo' has been bagged (good) but then left hanging on a fence or hedge (not good). Previous requests for a change of habit appear to have proven fruitless. Without wishing to use a sledge hammer to crack a nut, your suggestions as to how the Parish Council can go about solving this problem would be welcome. For example, some councils have used cameras and other technology to catch offenders. Should we consider going down this route?

END OF AN ERA AT CROSS TREE HOUSE, LOPEN
