The order comes into force on 14th. September 2017, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from the 17th. August 2017, make an application to the High Court.

The effect of the Order is to modify the definitive map and statement by adding the path or way described in the Schedule below.
