ROTHERHAM BOROUGH COUNCIL DEFINITIVE MAP AND STATEMENT
PUBLIC FOOTPATH NO. 15 - PARISH OF DINNINGTON AND PUBLIC
FOOTPATH NO. 44 - PARISH OF ANSTON MODIFICATION ORDER 2015

This Order is made by the Rotherham Borough Council ("the Council") under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Definitive Map and Statement (title as in the order heading) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the Act, namely, a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path. The creation of Public Footpath No 15 in the Parish of Dinnington and Public Footpath No. 44 in the Parish of Anston on 24th November 2015.

Rotherham Borough Council hereby orders that:

1. For the purposes of this order the relevant date is 24th November 2015.
2. The Dinnington and Anston Definitive Map and Statements (Public Footpath No. 15 in Dinnington and Public Footpath No. 44 in Anston) shall be modified as described in Part I and Part II of the Schedule below and shown on the map attached to this order.
3. This order shall take effect on the date it is made and may be cited as the Rotherham Borough Council Public Footpath No. 15 – Parish of Dinnington and Public Footpath No. 44 – Parish of Anston Definitive Map Modification Order 2015.

MODIFICATION OF DEFINITIVE MAP

Description of path or way to be added

Dinnington Footpath No. 15

Footpath commencing at its junction with Cramfit Crescent, grid reference SK 5209 8595 and proceeding in a south easterly then southerly direction to its junction with the parish boundary at grid reference SK 5215 8570, with a branch leading from grid reference SK 5215 8588 and proceeding in a north easterly direction to a point on Limelands Road at grid reference SK 5223 8592.

Anston Footpath No. 44

Footpath commencing at its junction with Edinburgh Drive to the east of Anston Greenland Junior and Infant School at grid reference SK 5206 8544 and proceeding in a north westerly then north easterly direction to a point on the Anston with Dinnington Parish Boundary at grid reference SK 5216 8570.

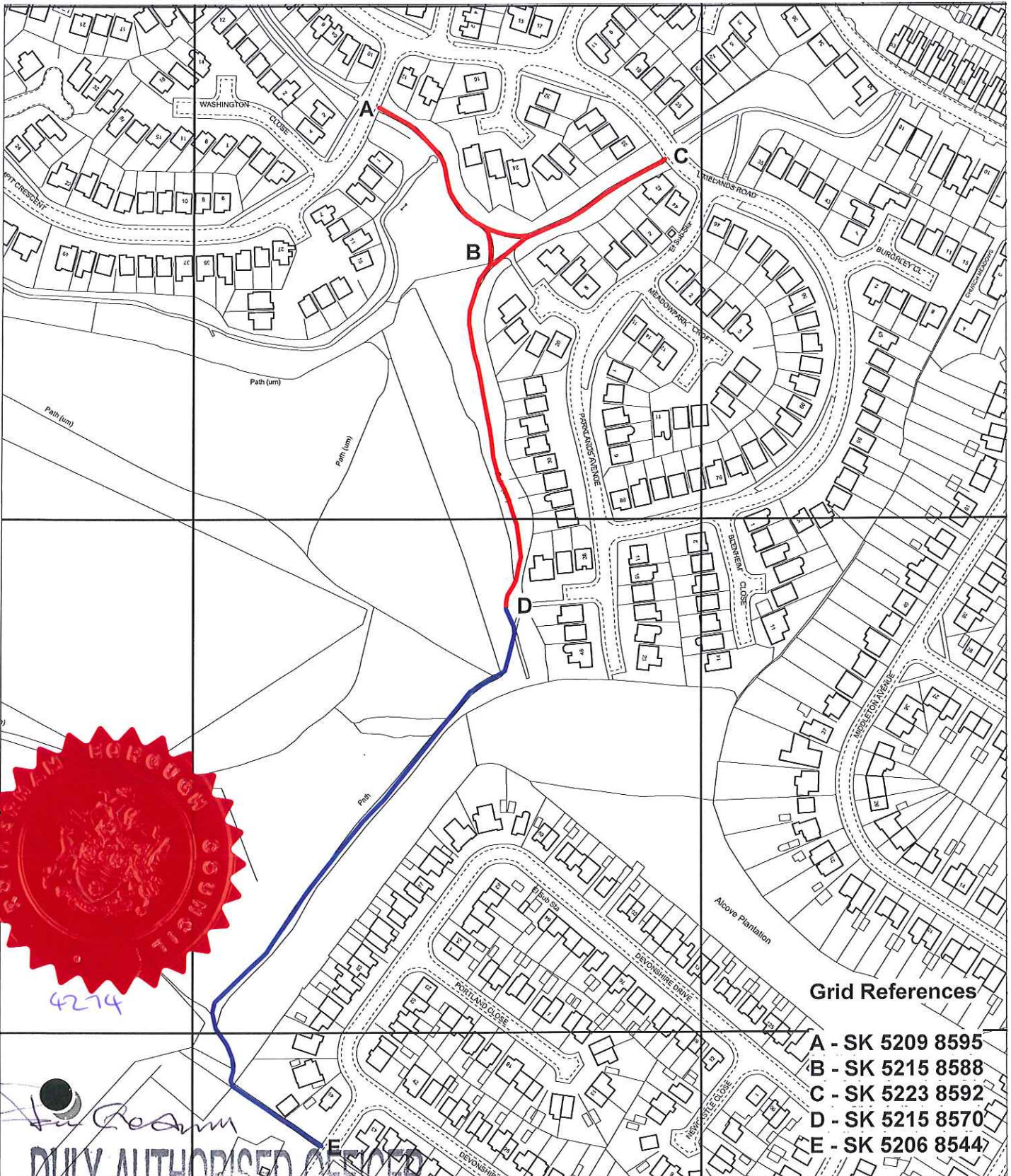
