##### Future of the Pub

The owners of the village pub attended the meeting to explain their intention to apply for planning permission to build a number of houses in the area of the pub garden and part of the car park. The garden is currently not well used by customers and they would like to raise sufficient money to refurbish the pub by selling the land with planning permission to a developer. They hope the Parish Council will support their application. If the application is refused it will be difficult to keep the pub open. If development is approved the intention is to refurbish the pub and hopefully attract more customers to make it viable in the long term.

The Chairman pointed out that as there is currently no application the Council cannot formally vote or express its opinion until there is an application to consider. The Chairman also suggested the owners might like to conduct a door to door survey of village residents to see if they will support an application and if they would support the pub once it is improved. SSSDC would take into account support from the village.

#### 2015/115 Report by County Councillor

The County Councillor's report was circulated by email and there were some hard copies available. There were no questions by Councillors regarding the report.

#### 2015/116 Minutes of meeting of the Parish Council held on Tuesday 9th June 2015

#### 2015/117 Matters arising from the minutes and any subsequent action taken

Minute 2015/108(c) - Land by the Ford - No reply has been received to date from Parrett Internal Drainage Board regarding ownership / responsibility for land by the Ford.

#### 2015/118 Highways

Speed Limit Reduction Cad Road - Highways have confirmed that the work should cost £2,000 and if the Parish Council are still willing to contribute 50% towards the cost, the work should be finished within 3 - 4 months. Councillors agreed to make the 50% contribution and the Clerk will inform Highways.

#### 2015/119 Brook Green

### **2015/120 Footpaths**

The County Council are running an 'Adopt a Footpath' scheme to encourage local people to walk the footpaths and / or report problems and help keep the paths open. The parish PPLO will act as co-ordinator. SCC will supply any necessary equipment, training and insurance.

There have been no reports of any problems and some strimming has been done, probably by SCC's footpath team. There are no updates on the bristol gate along Cad Road.

### **2015/121 Cemetery / Churchyard**

- (a) Councillors have walked around the Cemetery and Churchyard and no problems have been reported. Everything is looking nice.
- (b) Gravestone at Churchyard - The plinth of the leaning stone has been cleaned and re-cemented in position and is now safe.
- (c) Hedge at Cemetery - This was overgrown and has now been cut by the SSDC team and is looking good.
- (d) Fir Tree Stumps - SSDC have been asked for a quote for grinding the tree stumps.
- (e) Rubbish Bin at Cemetery - The new bin will be installed by Play UK.

### **2015/122 Recreation Ground**

- (a) The latest Inspection Reports show nothing new or urgent. The basket ball net has been replaced.
- (b) The dog bins and bin beside the fence have not been emptied. The Clerk to inform SSDC.

- (c) Councillors are looking at suppliers for picnic benches.  
**ACTION - Recreation Ground Officers**
- (d) There are a few final things to be finished - the trim trail, the remaining seating, moving the bin away from the fence and siting it in a more prominent position. The BMX track will be considered once the landscape architect has drawn up plans for the new Recreation Field. The BMX track may be left in the Recreation Ground for the younger children and a new skate park built in the new Field.
- (e) The Vice Chairman will do the official opening of the refurbished Rec at the Playday on Saturday 15th August. An Olaf mascot has been arranged at a special rate for the village. The Vice Chairman will inform the newspapers. **ACTION - Vice Chairman**  
The District Councillor will enquire about an ice-cream van.

The Youth Club Officer will enquire about a hot dog stall.

### **2015/123 Recreational Development / Playing Field**

- (a) Transfer of land - The Warren Trust's solicitors raised concerns about a risk of "enlargement" of any lease over 299 years in length. This means that it could

undermine any restrictive covenants on a lease and allow the lessee (ie Ilton Parish Council) to claim freehold of the land and remove any restrict covenants that the land must be used for recreational purposes.

The solution offered by the Warren Trust, to give the Parish Council the security we require, was that the lease would contain a clause giving "a right to extend for a further 299 years" which would be at no cost and be in perpetuity for the next lease etc. This essentially means the lease could continue forever. This also avoids an alternative proposal, seen as risky by the Trust's solicitors, to charge the Council a 'rent' of say £500 for 999 years which could be interpreted as not being a market rent and therefore raise the possibility that enlargement could still happen. Also the Warren Trust wish to give the land to Ilton and do not wish to charge for it, however small.

The new terms have been discussed with SSDC legal advisors.

Councillors agreed that the new terms are acceptable and a renewable lease for 299 years seems a good solution.

- (b) Landscape architect - SSDC have advised that Ilton wait until the lease is signed before a landscape architect is engaged. Once the lease is signed Ilton Parish Council will receive £210,000 to spend on the field. The developer also has to pay a strategic element in the 106 agreement which will be some £40 - £50,000 which Ilton should be able to keep. The whole project is worth about £ ½ million. The timescale is in the hands of the solicitors.
- (c) Goal posts - one has been painted; the second one is to be done.
