BBC Children in Need Grants Programme is Open to Applications

Small grants and Large grants are available to not-for-profit organisations in the UK that are supporting children and young people of 18 years and under who are experiencing disadvantage through:

- Illness, distress, abuse or neglect.
- Any kind of disability.
- Behavioural or psychological difficulties.
- Living in poverty or situations of deprivation.

Organisations must be working to combat this disadvantage and to make a real difference to children and young people's lives.

To be eligible, projects should:

- Take the initiative and show clearly how they will make a difference in children and young people's lives.
- Address the challenges the children and young people face, build their skills and resilience, empower them and extend their choices in life.
- Involve children and young people in the design, delivery and evaluation of their work.
- Be keen to keep learning about their work so that their ability to make a difference in children and young people's lives can keep on improving.

Applications can be made for either of the following:

- Main Grants of over £10,000 can support projects for up to three years. Small Grants of up to £10,000 can support projects for one year.

The deadlines for Small Grant applications are 1 June, 1 September, and 1 December 2016.

The deadlines for Main Grant applications are 15 May and 15 September 2016

Macmillan - Supporting You to Help Others Grants: Round Two Deadline in May

The Supporting You to Help Others Grants programme aims to provide people affected by cancer with opportunities to use their experiences to support others, while also receiving support themselves.

The grants programme especially welcomes applications that contribute to achieving Macmillan's Inclusion vision of a health and social care system where equal access to, and delivery of the best cancer services are available to everyone living with and beyond cancer.

Individuals or groups of people affected by cancer, as well as organisations and professionals working in partnership with people affected by cancer in the UK can apply for funding.

The following grants are available:

- Start-up fund to support the start-up of a new self help and support project for people affected by cancer.
- Development funds to support the ongoing activities and development of self help and support projects for people affected by cancer.
- User Involvement Grants to encourage the involvement of people affected by cancer in the design and improvement of cancer services.
- Individual Development Grants to enable people affected by cancer to develop their skills and use their cancer experience to help support others affected by cancer.

There are three levels of funding:

- A maximum of £500 for projects that have been running for less than 12 months.
- A maximum of £3,000 for projects that have been in existence for more than 12 months.
- Individual development - the actual cost of the activity (or the requested level of contribution to it), plus associated costs such as travel, accommodation, for a maximum of two people per group (if applicable).

The deadline for Round 2 applications is 13 May 2016.

National Vegetarian Week 2016 Event Grants - Launches for UK Groups

The Vegetarian Society is providing small grants of up to £200 for events and activities taking place from 16 to 22 May 2016 that attract those beginning their vegetarian journey, meat-reducers and the veggie-curious, but are inclusive of the wider vegetarian community.

The grants are to be used for events and activities that:

- Take place during National Vegetarian Week (16-22 May 2016).
- Celebrate and promote vegetarianism.
- Are exclusively vegetarian. (Events cannot have non-vegetarian food or drink).
- Promote National Vegetarian Week exclusively as the primary purpose of the funded activity and tie in with the theme: 'Celebrate your food, stories and traditions'.

Examples of events and activities, could include, but are not limited to:

- Cookery demonstrations.
- Communal meals.
- Recipe exchanges.

The deadline for applications is 9 May 2016 (9am).

Power to Change - Community Business Fund Opening Soon

Power to Change is providing the new £10 million Community Business Fund to support the development of sustainable community-led enterprises across England to help more people respond to local need and opportunity, and change the places in which they live for the better.

Grants of between £50,000 and £300,000 will be available over three funding rounds to help existing locally based and community-led businesses in England to increase their social impact and make them more viable in the long term.

The grants can be used for the following:

- Capital costs including building, vehicles, equipment of significant value, refurbishment costs.
- Project-specific revenue costs like staff costs, professional fees, volunteer costs.

The fund opens to online applications from 26 April 2016.

Lord's Taverners' Minibuses

Lord's Taverners provide accessible transport for schools catering for young people with disabilities.

These iconic green minibuses enable schools to engage pupils in sporting and recreational activities and help them develop life skills such as visiting shops and interacting with people in the local community. Most importantly, the minibuses provide transport to and from school.

Since 1976 the Lord's Taverners has put over 1,110 accessible minibuses on the road across the UK.

The Lord's Taverners Charitable Programmes Team process applications for the minibus programme twice yearly. **The application form will be available for download and completion between the following dates: 1st May to 29th July 2016.**

All applications must be received before the closing dates shown above, if received after the closing date the application may be held for consideration during the next application period.

Once they have received your application they will review the form and may ask one of the many regional volunteers to visit you and discuss your application in more detail.

Tesco's Bags of Help Scheme

Tesco Bags of Help scheme second round of funding re-opens for applications on 18th April 2016.

Bags of Help is administered by Groundwork and funded by Tesco customers from the proceeds of the 5p charge for plastic carrier bags.

The scheme is open to community groups across England, Wales and Scotland to apply for grants of £8,000, £10,000 and £12,000 to improve local green space.

Online applications will be accepted from a wide range of organisations including: voluntary/community organisations, registered charities, schools, health bodies, Parish/Town councils, social enterprises, Community Interest Companies, community councils, local authorities and housing organisations. Other not-for-profit organisations might also be eligible.

Tesco customers will be able to cast their vote on which shortlisted project in their area they would like to see receive the top grant from 1 October 2016.

Deadline for applications is June 2016 (exact date TBC)

Weaver's Company Benevolent Fund

Weaver's Benevolent Fund supports small, registered charities undertaking projects involving young people who are vulnerable or may become involved in crime.

Grants are usually up to £15,000 per annum but smaller applications are also welcomed. Grants may be awarded for up to three years.

To be eligible for funding, local organisations such as those working in a village, estate or small town should normally have an income of less than about £100,000. Those working across the UK should normally have an income below £250,000.

The scheme particularly wishes to fund projects that work:

- With disadvantaged young people between the ages of five and 30, to ensure that they are given every possible chance to meet their full potential and to participate fully in society
- To address the social and economic problems faced by offenders and ex-offenders under the age of thirty and their families and provide them with the support and training they need to return to employment or education.

Priority will be given to smaller organisations which offer direct services. Local organisations such as those working in a village, estate or small town should normally have an income of less than about £100,000. Those working across the UK should normally have an income of not more than about £250,000.
