It's the Guild ... Marathon - 28 October 2012

The Preston Guild Marathon and Half Marathon is the third event in a four part race series and forms part of the celebratory programme of events for the Guild. The marathon and half marathon will be run this Sunday 28th October. All races start and finish from Preston Flag Market in the city centre. The full marathon runners are first to face the starting pistol at 9am, followed by the half marathon at 10am. The 11-17 year olds running the 4.7km mini marathon route set off at 10.15am. The first runners for the half marathon are expected to cross the finish line around 11am and around 11.20am for marathon runners. A number of road closures will occur throughout the city centre to accomodate the runs. Between the hours of 8am and 5pm a number of the roads will be temporarily closed to any motor vehicle or cycle. The prize giving ceremony will take place at Race HQ in Preston Guild Hall from 1pm and spectators are invited to come along and watch the ceremony. Top prize for marathon runners is £250, half marathon £200. The fourth and final race of the Guild series is

the Preston 10 miler on Sunday 18th November.

MP says criminals who cannot pay fines should pay off debt through work for charities

We were rather stuck where to put this article but, in keeping with the spirit of the DWP, decided to put it under "volunteering".

Criminals who cannot pay fines imposed by courts should instead be made to work for charities to pay off the

fine, a bill introduced to parliament yesterday proposes. In a Ten Minute Rule bill, John Glen, the Conservative MP for Salisbury, said local authorities and voluntary organisations should be given the power to supervise "unpaid work orders" whereby people who could not pay cash for a court fine instead paid it off with their labour, at a designated hourly rate. Glen was given permission to continue with the bill, but has no plans to do so because the Ministry of Justice has specifically said it has no plans to introduce unpaid work orders.

David Cameron announces large increase in payment-by-results schemes to tackle reoffending

David Cameron, the Prime Minister, has said he wants to see a large increase in the use of payment-by-results schemes to prevent reoffending. "By the end of 2015, I want to see payment by results spread right across rehabilitation," he told an event hosted by the Centre for Social Justice think tank. "Of course, there will be some high-risk offenders for whom this is not appropriate, but this approach should be the norm rather than the exception." He said that payment by results for rehabilitation was "such a good idea I want to put rocket boosters under it". "To achieve that, we're saying to charities, companies and voluntary organisations – come and help us rehabilitate our prisoners." The government has not yet said what funding will be made available for the scheme.

Cabinet Office to help community organisers with £7.5m of start-up grants

The Cabinet Office is to invest up to £7.5m in bursaries to help recruits on its community organisers programme secure employment once their year-long training ends. The government's community organisers programme is training 5,000 people to work in communities to create local networks and encourage local people to take action in their areas. Of these, 500 will be paid senior organisers and the rest will be volunteers. When the programme was launched last year, the Cabinet Office said that the senior organisers would receive a £20,000 bursary only in their foundation year, and would then have to seek additional funding from sources such as foundations and local authorities when their training finished. But a spokeswoman for the Cabinet Office confirmed in a statement that it was now making employment start-up grants of up to

£15,000 to organisers who had completed their 51 weeks of training and who had raised the same amount in match funding.

Charities might have to read '100 pages of guidance' to use new Gift Aid scheme

Charities that want to use the Gift Aid Small Donations Scheme could have to read almost 100 pages of guidance before they can do so, according to Gareth Thomas, the shadow charities minister. Thomas was speaking in Parliament during the committee stage of the Small Charitable Donations Bill, which will introduce GASDS. "There are 80 pages of guidance for a charity to claim Gift Aid," Thomas told fellow MPs on bill committee last week. "Further guidance will be published by HM Revenue & Customs about the implementation of this scheme."

The Local Government grant settlement ends in March next year - the government is currently consulting on new arrangements for Local Government finance beyond that. Preston: Social housing wait soars

The number of people waiting for social housing in Preston has increased by almost a quarter. There are now 2,617 people waiting for homes compared to 2,149 this time last year. The figures, from Community Gateway's annual report, reflect changes in the welfare system which place limits on the amount of housing benefit available to families.

Extra 10,000 working people a month reliant on housing benefit, says report

The number of working households forced to rely on housing benefit since the recession began in 2008 has doubled – a trend that will lead to a million earners being dependent on welfare to keep a roof over their

heads by the next election, according to a report. As private rents rise faster than wages, another 10,000 working people a month need housing benefit to afford their rent. By the next election, the study warns, 1.2 million "strivers" will only be able to stay in their homes through welfare payments. In Preston, the average annual rent takes up 38% of the average income, in Chorley 39% and in South Ribble 41%. http://www.housing.org.uk/

Councils way off 120,000 troubled families target

Councils are struggling to identify anywhere near the 120,000 'troubled families' that ministers claim exist in England, an LGC investigation suggests. Responses from a third of England's upper-tier councils that are participating in the scheme run by the Department for Communities & Local Government suggest that councils have identified just 6.9% of their target number of families meeting the government's strict definition of 'troubled'.

Partnership working must focus more on needs of beneficiaries, says report

Charities and voluntary organisations are not doing enough to prioritise the views and needs of beneficiaries when considering partnership working, a new report suggests. Partnership Working, published by the Third Sector Research Centre, says service users' views are too often being excluded when objectives for partnership are being set or assessed for impact.

Councils wasting resources by keeping advice services in-house

Local authority youth services are increasingly trying to deliver one-to-one advice and support themselves even though the evidence is clear that the voluntary sector does it more effectively. Youth Access today launches the results of its annual survey of the financial health of youth information, advice, counselling and support services. The report shows that these services are 'Stretched to the Limit', desperately trying to protect vital front-line services upon which young people depend despite increasing demand and diminishing resources. Chaotic commissioning practices and the protection of local authority jobs are exacerbating the plight of effective voluntary sector services in many areas.

Hodgson Review debate continues

The proposal to allow large charities (defined as those with annual incomes in excess of £1m) to pay their trustees without the Charity Commission's consent lacks support and would be damaging to public confidence and the charity sector, sector leaders have warned Nick Hurd, the Minister for Civil Society. A joint response from the chief executives of the umbrella bodies Navca, Community Matters and the Small Charities Coalition

and a separate response from the policy body the Directory of Social Change, both warn against introducing the measure, proposed by the Conservative peer Lord Hodgson in his review of the Charities Act 2006. Navca, Community Matters and SCC also caution against introducing charges for registration and filing accounts with the Charity Commission because it would disproportionately affect smaller charities. The response from the three organisations also says the proposal to raise the annual income threshold for compulsory registration with the commission from £5,000 to £25,000 requires more thought. "Registration with the Charity Commission is vital for fundraising because a significant number of trusts and foundations do not support unregistered charities," the joint response says. The joint response says that the suggestion that charities with incomes of less than £25,000 a year should be listed as "small" on the commission's register could create a two-tier system. Appearing before MPs on the Public Administration Select Committee, Hodgson however said larger charities were "big businesses" and that it was right to allow such organisations to pay trustees in order to get the right people and that trustees should be encouraged to use their judgement.

Free Guide Can Help Charities Adopt Social Enterprise Approach

The new free guide has been published in response to a call from the charitable sector for information and advice on how to become a social enterprise as they look for ways to deal with an environment of diminishing funding. Social enterprises are organisations that trade for a social and/or environmental purpose. It is estimated that there are more than 68,000 social enterprises in the UK, and they contribute at least £24 billion to the economy. These numbers are expected to increase as social investment takes off and the Public Services (Social Value) Act comes into force in January 2013. It is hoped the Act will create more trading opportunities for charities and social enterprises providing public services.

Fears over Preston's toll of booze-related disease

Preston has one of the highest rates of liver disease in the North West, a new report has revealed. And the city has the fourth highest level of deaths from alcohol-related liver disease, according to research from the North West Public Health Observatory. Alcohol Concern chief executive Eric Appleby said: "It is the common perception that young people are responsible for the increasing cost of alcohol misuse, but our findings show that in reality this is not the case. "It is the middle-aged, and often middle class drinker, regularly drinking above recommended limits, who are actually requiring complex and expensive NHS care."
