3. Planning Review in England

The Department for Communities and Local Government has begun a consultation to seek views on the Government's proposals to amend the Town and Country Planning (General Permitted Development) Order 1995 (as amended) to grant permitted development rights to changes of use from commercial to residential, i.e. to allow such changes of use without the need for planning applications. The changes will apply to England only but the documents do not make reference to any protected species, including bats. The consultation closes on 30th June 2011. 4. Government's "Red Tape Challenge"

The coalition government has set us all a 'Red Tape Challenge'. They are inviting us to tell them what we think should happen to a huge raft of UK regulations and why. The regulations open for review include environmental regulations and can be found under "general regulations" (comments welcomed throughout the process). In short, it seems the government is considering getting rid of 278 environment laws (among thousands of laws and regulations), 159 of which relate to biodiversity, wildlife management, landscape, countryside and recreation (including WCA 1981, CROW 2000, Habs Regs 2010 etc.) as part of its 'Red Tape Challenge'. The Cabinet Office is seeking proposals for which laws should be scrapped, with Ministers facing a basic presumption that laws and regulations listed in the Red Tape Challenge should be scrapped. Once the nation has had its say, Ministers will have three months to work out which regulations they want to keep and why.

The website lists the 278 environmental regulations under scrutiny and your comments (either as an individual or as a Bat Group) can be left under 7 broad headings. HBRC OUTDOOR RECORDERS MEETING AT BYTHAN, AVENBURY

This year with kind permission from Hilary and Peter Hillier we will be holding the event at their home in Avenbury on **15th and 16th of June 2011.** The site has a good mixture of habitats including orchards, unimproved grassland, woodland, veteran trees, ponds and also a W.E.T. system created to deal with effluent. There are also some beautiful views across the local landscape.

For those of you who attended last year's meeting at Turnastone Court this event will follow a similar format. It will begin on the evening of the 15th of June which will allow us to record nocturnal species and also provide an opportunity for traps to be set that can then be checked on the 16th - the main day of recording. Recorders will be able to access the many habitats present throughout the day and the event will end with an opportunity for informal discussion about the species recorded and any management issues and advice that may be offered by recorders.

I hope that you will be able to attend one or both of the days. The start times have yet to be confirmed, but are likely to be around 7pm on the 15th and 9.30am on the 16th.

CARING FOR GOD'S ACRE IS SETTING ITS CHURCHYARD TASK TEAM THE CHALLENGE OF IMPROVING THE BIODIVERSITY AT ST WEONARD'S CHURCHYARD IN 2011. BUT WE NEED TO KNOW WHAT IS THERE NOW......

We would like to invite yourself or your group to come along, preferably on the 20th or 21st June to conduct a survey of the wildlife in the churchyard. The areas included are the church, walls, monuments, trees, old grassland around the church, the new burial area, and the meadow area – a possible future green burial ground.

We realise that it might not be the best time of year for your particular wildlife speciality, but any records collected from now until the end of August would be very valuable to us.

The programme for the event will be:

Monday 20th June: Start at 1900 with small mammal surveys, moth traps and bat surveys until around midnight.

Tuesday 21st June: Dawn bat survey starting at 0330, small mammal trapping, moth identification.

0900-1000 - Reptile and amphibian surveys (refugia)

1000 – 1530 Open for all possibly including school groups. If you would be happy to talk to small groups of people about how to find and identify your particular wildlife, please let me know your preferred time of day if any.

The church is equipped with kitchen and toilet facilities, and indoor space for stalls or exhibitions. If you would like to have a table or stall provided please let me know. Drinks and cakes will be provided through the day. (Some mileage expenses can be reimbursed if agreed prior to the event).
