17.145	These were AGREED as a true record of the meeting, and signed as such by Cllr Tordoff as Vice-Chair in

17.140	It was RESOLVED to approve the following payments:

17.147	Planning applications and decisions
17.147.1	Applications: The Council discussed application 18/00294/FUL at the Coach House, Bishop's Palace,
	Ripon and AGREED that it had no objection.
	The Council then discussed application 18/00569/SCOPE from North Stainley Estates, for an
	Environmental Impact Assessment (EIA) Scoping Opinion which had been received on the afternoon of
	the meeting. Not having been asked for a Scoping Opinion for some time, it was AGREED to seek
	clarification about the nature of the decision required here. Action: Clerk to consult HBC Planning and SLCC planning specialist
	From the documents sent it seemed to be that the applicants were asking the planning authority not
	to undertake an EIA as all aspects of it would be covered in their forthcoming outline application for
	the North Stainley Village development.
	The Council AGREED that: if this were indeed the case they would object, on the grounds that an EIA
	should be undertaken for a project of such a scale; but that if this were not the case they would
	reconsider based on advice received, possibly at an extraordinary meeting.
	Action: Clerk to report to HBC planning as appropriate
	Clerk's note: HBC confirm [15/2] that this is essentially the case, but that the council is being
	consulted for comment as this is part of a consultation rather than an application to support or
	object. Therefore the parish council will "neither support nor object" while offering as a comment
	that an EIA should be undertaken.
	<i>Clerk's note to parishioners: for clarity, this is not an application for planning permission for any or all of the proposed North Stainley Village development, rather part of the preparation for one.</i>

	The council also noted case 18/00012/PR01 regarding Tanfield Bridge, which is presumed to be as a
	result of the concerns raised by the council in November [minute 17.120]. However the nature of the
	complaint has been summarised as "unfinished works to Tanfield Bridge" whereas the council's
	concern had been that the bridge had been altered without listed building consent. The Clerk had informed the officer of this by email but has not as yet had a response.
	Action: Clerk to maintain communication with HBC planning

17.148.1	Angela Evans, Harrogate BC Finance; confirming receipt of 2018-19 precept requirement in good order.
17.148.2	Nicola Moorcroft, YLCA; notification of a successful application to the Smaller Authorities Transparency

17.148.3	Wicksteed Ltd; annual play area manufacturers safety inspection is due. After a brief discussion it was RESOLVED to commission this, in addition to the monthly inspections by the parish caretaker.
