The Parish Council met on 15th May and 19th June and considered a number of items.

NEW SCHOOL

Richard Plummer (Chair of Governors) and Elizabeth Watts (Headteacher) attended the Parish Council's meeting in June to speak about their ambition to build a new school in North Stainley.

It was noted that this project is in the very early stages and that the whole community will be fully consulted in due course.

The current school building is not considered fit for purpose, nor is it large enough to serve a village the size of North Stainley.

A number of sites around the village are being considered, one of which is Front Field which had previously been earmarked for allotments.

The Parish Council has agreed to put the allotment project on hold to allow the School's project team to carry out a site analysis in conjunction with the landowner.

HOLIDAY RESORT

The Parish Council has considered revised proposals for a holiday resort at Lightwater Valley. These now comprise of 106 lodges. It is expected that a planning application will be submitted later in the year.

The Parish Council has agreed that there are a number of issues / aspects which need addressing, including:

- Whether the lodges will be owned or holiday lets.
- Improvements to the entrance from the A6108.
- Possible benefits for North Stainley.
- Evidence of need for the development.
- Continued investment in / improvements to the theme park.
- Theme park traffic at the Clock Tower junction.

Watch out for details of an exhibition / consultation being carried out in North Stainley Village Hall.



SPEEDING ON WATERMILL LANE
