VILLAGE DEVELOPMENT

New School

Richard Plummer, Chair of Governors, attended to give an update on proposals for a new school in North Stainley. A new building is required to help secure the future of the school because the present site is too small for the current and projected roll and because it is unsuitable in several other respects. These cannot be resolved as long as the school remains in its current location.

Although a number of locations are being considered around North Stainley village, Mr Staveley (landowner) has confirmed that his preferred site is currently Front Field - behind Lavender Lane, between the Ripon Rowel walk and The Staveley Arms.

The shortcomings of the current building and the fact that North Yorkshire County Council (NYCC) would not be required to fully fund the project means that they consider there to be a compelling case for a new school in North Stainley.

NYCC's Education Department has agreed to carry out a feasibility study to help determine how and where the project will proceed, including establishing an accurate cost for a new building.

The results of this study should be available to the School's governing body in October and so Mr Plummer was invited to attend the Parish Council's November meeting to give a further update on the project.

All those present at the meeting agreed the need for full public consultation with local residents. This will take place as soon as possible, but only when there is sufficient information available to enable people to come to an informed view on the project.

Housing Development

Mr Staveley used the meeting as an opportunity to stress that **there are currently no proposals for further housing development in North Stainley** (other than that which already has planning permission), or to fund the new school through further housing. This is due to a combination of market forces and Harrogate Borough Council's unwillingness to allow further development in the village during their current planned period.

Village Shop

Mr Staveley advised that he is in the early stages of working with architects on a scheme to redevelop the village shop. In view of the opinions given by the public at previous meetings this was welcomed by the Parish Council.

North Yorkshire County Council is proposing a new **Vehicle Activated Sign Scheme** whereby Parish Councils will be able to pay for units to be sited temporarily in their area. Further details are awaited as to the cost and frequency of visits to each site.
