SAWLEY TRAIL EQUIPMENT SCHEME

Thank you to everyone who came to Sawley Village Hall on 2nd March to give their opinion on providing play equipment on Sawley Village Green. 80% of people who came were in favour of providing this equipment. As this was the second public consultation with strong public support for the proposals **the Parish Council has agreed to proceed with a scheme** provided by Playforce (www.playforce.co.uk).

Some alterations have been made as a result of the feedback from the public so that everyone's favourite items have been included. The equipment will be located at the back, and along one side of the Green to minimise any impact. Taller items of equipment will be shielded by trees. The final scheme is now on display on the noticeboard in Sawley – come and have a look to see what is going to be installed in July.

The cost of the scheme is going to be £13,653.90. It is hoped that some grant funding can be obtained, but the Parish Room proceeds will be used to fund any deficit.

VACANCY ON COUNCIL

There is still a vacancy for another member on the Parish Council. The role takes about 2 hours a month (including bi-monthly meetings) and is interesting and varied. The Council is consulted on all planning applications, is responsible for two play areas, undertakes general maintenance in the parish, owns Picking Gill nature area and a whole lot more besides! SAWLEY SMALL GRANTS SCHEME

The Parish Council is once again inviting applications to the Small Grants Scheme from organisations and residents in the Sawley ward of the parish.

Grants can be used for a wide variety of purposes. Organisations should apply for funding for projects that will benefit the whole community. Individuals can apply for up to £200 to help towards project, scheme or course costs that will enhance their educational, sporting or cultural advancement.

PARISH ROOM PROCEEDS UPDATE

The total balance of the Parish Room Proceeds as at 31st March 2013 was £147,607.20, of which:

- \triangleright £117,277.25 was invested in three separate bonds.
- ➤ £3,670.62 is available for distribution through the Sawley Small Grants Scheme (see over).
- ► £26,243.04 is for capital projects such as improving recreation provision and a new bus shelter.
- ➤ £416.29 is being kept as a 'float' to cover any administrative costs
- £3,066.37 of interest was earned during the 2012/13 financial year.
- In 2012/13 the Parish Council awarded £665 of grants from the Sawley Small Grants Scheme to fund work by the Sawley Arts Group and to help towards the cost of two Sawley residents undertaking educational courses.
- The total cost of the works to Sawley Church Clock will be £5353.
- Money from the proceeds will be used to fund the new play equipment on Sawley Village Green (see overleaf).



MOTORCYCLE TRIAL NEAR LOW GRANTLEY



The Parish Council took up residents' concerns about bikes using the local roads for an event in April with the organisers, who've said that they're sorry for any disturbance caused. It is an annual event which is run under Auto Cycle Union (ACU) regulations with a registered steward in attendance. The Police are informed that the event is taking place when the ACU permit to run it is issued. The trial is run over three laps of observed sections on private land linked by public roads and there was signage on the route indicating what was taking place and cautioning riders to be aware of others.
