Members' Corner

Visit to the Highways Agency National Traffic Control Centre at Quinton, Birmingham on Monday 24th October.

The group of us travelling from mid-Wales to Birmingham went into cloud base on Clee Hill at 1250 ft. above sea level before arriving at the NTCC. There we were offered tea, coffee and biscuits by Ian Burgess, the Operational Partnerships Manager who gave us a detailed presentation of the work carried out in the building.

The aim of the Highways Agency is to have safe roads, reliable journeys, informed travellers and, as a consequence, improved journey times and less disruption caused by major incidents and road-works. In this way it can influence our decisions before we take to the road. The Agency manages 4,850 miles of motorways and trunk roads in England and the network carries two thirds of all freight in the country. Pause for a moment and think about that! Money to run the whole show is through a ten year Private Finance Initiative contract worth £160 million. Policy is set by the HA and implemented by their contractors, Traffic Information Services.

Mr Burgess explained how the NTCC works. It collects information from sources including the police, local authorities, HA traffic officers, road contractors, CCTV cameras, sub-surface monitoring loops and the weather centre. The HA then analyses that data and passes it on to all their source partners and, of course us, the road users.

Some events are known about and planned e.g. Formula 1 racing at Silverstone, Crufts dog show, abnormal loads, road works and so on. Unplanned events include congestion, accidents, and anything else that might have a material effect on the network for more than 15 minutes. Last September alone

the Agency handled 6,840 such events. Talk about a bad hair day! Their response is as appropriate, for example notifying the relevant police forces, putting messages on any of the 350 overhead illuminated sign boards, locally altering the speed limits, updating their web-sites and telephone services and setting diversions (via the sign boards). Some signboards activate themselves automatically when queuing is detected.

We then moved on to have a look at the Operations room. Our chairs were arranged facing blank frosted glass picture windows, which had us puzzled until Matt, the Operations Manager, pressed a light switch and all was revealed. We could see into his domain - a large room dominated by a wall of TV screens - one very big central screen flanked by panels of 12 screens. All of this was controlled by two teams of 8 staff, each with their own computer and four screens. They work in 12 hour shifts, 24 hours a day (24/7/365) and from here can view the whole of their road network in England.

A few facts. There are 1,010 automatic number plate recognition cameras; 700 CCTV cameras which can tilt, pan and zoom with optical definition precise enough to see if the chocolate wrapper on your dash-board is a Mars or a Yorkie; 1,900 sub-surface loops to detect congestion and 4,300 traffic reporting points.
