# **Editor's Spot**

The two articles which are printed below concerning driving tests and examiners set me thinking about the time I was learning to drive back in 1959. My father refused to let me get at the controls of his Ford Consul until I'd had "proper lessons" and even then he was somewhat sparing with his favours until he began to realise that I had the makings of a decent pupil.

I passed the test six months later which was surprising because an incident, potentially more serious than the one caused by Miss Kelly (see following article), occurred about half way through.

I was going along a road with cars parked both sides, and in front of me a man was walking round his vehicle to get in. I had plenty of time to give him space but I must have misjudged the situation because, as I drove past, he suddenly flattened himself against the door. On I went and finally reached the end of the test, certain that I'd blown it.

The examiner shuffled his papers. "Very good," he said. "You're a competent driver, although you did make that chap in Manor Road jump a bit sharpish. I think I'll pass you." And that was it – my luck was in! I drove my father home, and the same afternoon he allowed me to zoom off to Henley Regatta with four mates as passengers. If he was worried, he didn't show it.

Move on a generation and my son is learning to drive. He had to get by on "proper lessons" alone because the family car was on contract hire, and the insurance policy strictly excluded use by learners. My own contribution to his eventual success was limited to after hours sessions in Sainsbury's car park where we practised reversing and three point turns. Occasionally he would slip in a racing start just to break the monotony. In all, I got off pretty lightly.

He passed at the second attempt and got a company car almost immediately. His first assignment took him from Coventry down the M1 to Harley Street. If my wife and I were worried, we didn't show it. He's even bought an old banger for the purpose, which is still relatively undamaged. Being of an extremely serene disposition he's coping well. If he's worried, he really doesn't show it!

Last month an ITV news bulletin reported that a certain Miss Kelly had accidentally splashed a pedestrian while she was taking her driving test for the third time. However, rule 144 states that you must not "drive without reasonable consideration for other road users." Rule 147 says that drivers must "be careful of and considerate towards all types of road user."

Unfortunately for Miss Kelly, the examiner stuck to the letter of the law and failed her. She's probably applied for test no.4 already in the hope that she gets a sunny day for it.

So, would you have taken the same view the examiner or a more lenient one?

In March, 1937 the following article appeared in The Times:

It was announced yesterday by Mr A.T.V. Robinson, deputy secretary to the Ministry of Transport, that the date for the introduction of driving tests for new motor drivers had been postponed. He was extremely concerned about the qualifications of some of the applicants for posts as tester and spoke of the bad signals that they gave. Many did not know the basic signals as laid down in the Highway Code and one, when asked what the Highway Code was, replied that it was a little booklet published by a newspaper. Ignorance regarding traffic lights was also amazing, and only 6 out of 120 candidates examined knew properly what the sequences meant.

Mr Hoare-Belisha said he was sure that an effective system of tests would lead to a great reduction in road accidents. He looked forward to a time when every driver on the road would be a man of skilled prowess, just as every engine driver was
