#### SAFETY RULES FOR MASS

#### **OUTLINE OF THE HILL CHAPEL ROOF PROBLEM as at 12.10.21**

We are all aware of the problem with the roof of our church; we have the constant reminder of the temporary prop!

It is clear from the independent engineer's investigations that this problem stems from the roof refurbishment project in 2009, but the fault did not come to light until 2019.

As you may know we are making a legal claim against the consultants, Cassidy and Ashton (C&A), who, together with engineers John Davis, supervised the 2009 work. When the structural movement occurred in 2019 we contacted C&A; they assisted in the installation of the prop to keep the building safe and usable, but they did not pay for it – this was paid for by the parish.

An independent structural engineer was appointed and asked to produce a report on the faulty roof. The first draft of his report was received at the end of 2019. The report cited serious oversights in the design of the 2009 roof refurbishment work and it was sent to C&A and dialogue was opened with them in early 2020 to try and reach an out-of-court agreement.

Discussions were delayed in the first half of 2020 due to the pandemic and the sad death of Bob Barron. The man dealing with this at C&A also died.

By the middle of 2020 it became clear that C&A were not progressing the claim and we would need to go to the expense of appointing a solicitor. A solicitor was appointed in August 2020.

Following further dialogue with C&A a further specialist engineer's report was needed to establish the extent and cost of the remedial work. This would obviously incur more up-front costs. We decided to instruct the engineer in March this year. By July all reports and costs were assembled and sent to C&A with the threat of legal action.

Time has been given to C&A and their sub-consultant, John Davis, to consider their position and hopefully agree to meet and settle the matter without resort to legal proceedings. There has been a further delay due to the illness of Mr Davis but it is now becoming increasingly clear that we will probably need to take the serious and costly decision to issue legal proceedings. The legal proceedings must be issued before year-end due to legal time limitations on claims of this nature; issue of proceedings cannot be taken lightly since it is costly, involving the appointment of a barrister.

We believe we have a sound, winnable case but there is always risk in taking court action. However, legal proceedings will be issued in the next few weeks unless an eleventh-hour offer to settle is forthcoming.
