# Structure, governance and management

Type of governing document	The governing body of the United Reformed Church is General Assembly. The United Reformed Church Acts 1972, 1981 and 2000 gives the authority under which General Assembly acts. These Acts of Parliament together with the Basis, Structure and Rules of Procedure of the United Reformed Church (as contained in sections A-C of the Manual of the United Reformed Church) contain the foundation documents of the church. The Title Deeds for the Trust known as the United Reformed Church Annan (formerly Congregational Church Annan) were constituted under Feu Charter and recorded with the General Register of Sasines, County of Dumfries on 5th July 1902.	
Trustee recruitment and appointment	Those responsible for the general control and management of the administration of the charity in relation to United Reformed Churches are the Elders of the church and the Minister. The congregation call the Minister, who is an ordained Minister of Word & Sacrament in The United Reformed Church; the Elders are elected by the church meeting and ordained as Elders of the United Reformed Church

Summary of the main activities in relation to these objects	The church has a full programme of Worship & Non-Worship events. Our worship services are held at 11.00am(GMT) or 10.30am(BST) each Sunday. During 2018 the church has continued to review how it might structure itself & prioritise for its mission in the next decade. We are committed to exploring the faith as faith for the 21 <sup>st</sup> Century. We take exploring the faith to be a journey in which we can engage & affirm the struggle to live in unity with a variety of views & insights about God. We are a caring Christian Community looking to care for each other & in the community. We endeavour to make our building available for the community & as such have within the last few years refurbished the ground floor of the church & the Hall kitchen so that our premises can best be utilised to suit the requirements of today's society.

Summary of the main achievements of the charity during the financial period	As part of the churches 'outreach' to the world church the congregation give regularly & generously to Christian Aid through the United Reformed Church <i>Commitment for Life</i> Project in Bangladesh (£530) and to several other charities e.g. Malawi Project (£373), Christian Aid (£166), & Soul Soup (Dumfries) (£136) The United Reformed Church Annan is nationally recognised as a <i>'Fairtrade'</i> church. Throughout the year our church premises are used by both church & local organisations thus allowing us to <i>'outreach'</i> further into the local community. Organisations such as <i>Friday Fellowship</i> , 1 <sup>st</sup> <i>Annan</i> <i>Company Girls' Brigade, All Age/All Abilities Games, Knit &amp; Natter</i> <i>Group</i> and the <i>Floral Art Club</i> are all organisations attached to the church and the United Reformed Church Annan, is the recognised parent body. We also provide accommodation on a weekly basis for <i>The Rainbow Tribe ecumenical youth singing group &amp; Spectrum</i> <i>Ceilidh Band</i> and on a monthly basis for the <i>Annandale &amp; Eskdale – Safe &amp; Healthy Action Partnership – Arts &amp;</i> <i>Crafts Group</i>

Brief statement of the charity's policy on reserves	As of June 2016 all of the church funds are held solely in our General Account. Trustee's guidelines require that the church endeavour to maintain the level of reserves held within the General Account at approximately 50% of the churches annual expenditure.
Details of any deficit	In 2018 the Unrestricted Funds i.e. the General Account, shows a surplus of £9939 A reduction in our payment to the URC Ministry & Mission Fund together with donations which were received in order to help pay for the repairs to the roof together with the proceeds from the manse rent all helped to realise this figure. Overall receipts in 2018 were higher than in 2017, and although we have seen a decrease in the Free Will Offering, the HMRC Tax Repayment together with the totals realised from our fundraising activities are marginally more than in 2017.

## Other optional information

#### **Financial Review**

In accordance with the current accounting regulations governing Scottish charities, the accounts are presented on a Receipts and Payments basis. The charity's Statement of Balances is enclosed with this document.

Salient features of the accounts: The churches main source of income is from the Freewill Offering and Plate ( $\pounds$ 17,686); as in previous years we also had a Vestry Day which in 2018 raised the sum of  $\pounds$ 1,835. Throughout 2018 the Fund Raising & Social Committee also raised  $\pounds$ 6,526 for church funds. The church also benefits from the Inland Revenue Charity Repayment, which is made as a result of our claim for monies received as Gift Aid donations ( $\pounds$ 6,492) and also from donations which this year totalled  $\pounds$ 8,371.

**Payments to Charity Trustees:** During the year payments made were to the Revd Haydn H Higton, Mr John J Murray & Mrs Margaret Jones. Revd Haydn H Higton received a pulpit supply fee of £40 on eight occasions for leading worship, Mr John J Murray received a pulpit supply fee of £40 on four occasions for leading worship & Mrs Margaret Jones received a pulpit supply fee of £40 on two occasions for leading worship.

Although the United Reformed Church Annan is in vacancy we continue to make a contribution to the **Ministry and Mission** Fund which in 2018 totalled £18,000 (2017 - £21,600)

*Church Buildings and Manse:* Having been advised by the National Synod of Scotland that as the United Reformed Church Annan retained the Church Title Deeds at the time of Unification in 2000 then the church buildings & manse are owned by the local church i.e. The United Reformed Church Annan & as such the Church Buildings & Manse are included as an asset on the Statement of Balances.

The local church (United Reformed Church Annan) is responsible for the maintenance of the buildings ensuring that they remain wind and watertight. Any structural or cosmetic changes to the buildings can only be carried out with the approval of the National Synod of Scotland.
