## Structure, governance and management

### Type of governing document

The governing body of the United Reformed Church is General Assembly. The United Reformed Church Acts 1972, 1981 and 2000 gives the authority under which General Assembly acts. These Acts of Parliament together with the Basis, Structure and Rules of Procedure of the United Reformed Church (as contained in sections A-C of the Manual of the United Reformed Church) contain the foundation documents of the church. The Title Deeds for the Trust known as the United Reformed Church Annan (formerly Congregational Church Annan) were constituted under Feu Charter and recorded with the General Register of Sasines, County of Dumfries on 5th July 1902.

### Trustee recruitment and appointment

Those responsible for the general control and management of the administration of the charity in relation to United Reformed Churches are the Elders of the church and the Minister. The congregation call the Minister, who is an ordained Minister of Word & Sacrament in The United Reformed Church; the Elders are elected by the church meeting and ordained as Elders of the United Reformed Church

## Objectives and activities

#### Charitable purposes

To further the religious and charitable work of the church within the local community and beyond.

The charity's restrictions and organisational structure can be found in the Manual of the United Reformed Church (Sections B and D).

# Summary of the main activities in relation to these objects

The church has a full programme of Worship & Non-Worship events. Our worship services are held at 10.30am each Sunday. During 2020 the Elders have continued to review how they might restructure the church for its mission in the next decade. We are committed to exploring the faith as faith for the 21st Century. We take exploring the faith to be a journey in which we can engage & affirm the struggle to live in unity with a variety of views & insights about God. We are a caring Christian Community looking to care for each other & in the community. We endeavour to make our building available for the community & as such have within the last few years refurbished the ground floor of the church & the Hall kitchen so that our premises can best be utilised to suit the requirements of today's society.

# **Achievements and performance**

Summary of the main achievements of the charity during the financial period

As part of the churches 'outreach' to the world church the congregation give regularly & generously to Christian Aid through the United Reformed Church *Commitment for Life* Project in Bangladesh (£420) and to other charities e.g.

Malawi Project (£53) & Fishermen's Mission (£20)

The United Reformed Church Annan is nationally recognised as a '*Fairtrade*' church.

Throughout the year our church premises would normally be used by both church & local organisations thus allowing us to 'outreach' further into the local community. Organisations such as *Friday Fellowship*, 1<sup>st</sup> Annan Company Girls' Brigade, All Age/All Abilities Games, Knit & Natter Group and the Floral Art Club are all organisations attached to the church and the United Reformed Church Annan, the recognised parent body.

We also provide accommodation on a weekly basis for

The Rainbow Tribe ecumenical youth singing group & Spectrum Ceilidh Band

and on a regular basis by

Annandale & Eskdale – Safe & Healthy Action Partnership – Tuesday Tots(weekly)& Arts & Crafts Group(monthly)

As well as a Disability Sport Group(weekly)

Sadly due to the Covid-19 restrictions all the groups named above have been unable to meet in our premises since mid-March but it is hoped that they will all return once it is safe to do so.

### Financial review

# Brief statement of the charity's policy on reserves

As of June 2016 all of the church funds are held solely in our General Account. Trustee's guidelines require that the church endeavour to maintain the level of reserves held within the General Account at approximately 50% of the churches annual expenditure.

#### Details of any deficit

In 2020 the Unrestricted Funds i.e. the General Account, shows a deficit of £2275. The church has been closed since 22<sup>nd</sup> March 2020 with no services or Fund Raising activities taking place. But we have continued to make our pledged payments to the URC Ministry & Mission Fund. Overall receipts in 2020 were much lower than in 2019, this is primarily due to the Pandemic since we were unable to hold our Vestry Day or monthly Fund Raising events. We have seen a marked decrease in the Free Will Offering & Plate as well as our Fundraising Activities from events held prior to 22<sup>nd</sup> March. Adding the HMRC Tax Repayment together with donations has still led to the figure being substantially less than in 2019.

# Other optional information

### **Financial Review**

In accordance with the current accounting regulations governing Scottish charities, the accounts are presented on a Receipts and Payments basis. The charity's Statement of Balances is enclosed with this document.

Salient features of the accounts: The churches main source of income is from the Freewill Offering and Plate (£6,230). The church also benefits from the Inland Revenue Charity Repayment, which is made as a result of our claim for monies received as Gift Aid donations (£5691) and also from our Fund Raising activities (£1,534) and donations which this year totalled £1449. **Payments to Charity Trustees:** During the year under review payments were made to the Revd Alan P Poolton and the Revd Haydn H Higton.

Revd Alan P Poolton was paid the nationally agreed Ministers stipend for part time ministry from the **United Reformed Ministry and Mission Fund**. Expenses totalling £899 was also reimbursed to the Revd Alan P Poolton to cover costs incurred whilst carrying out his ministerial duties.

Revd Haydn H Higton received a pulpit supply fee of £40 on one occasion for leading worship.

Although temporarily closed from the 22<sup>nd</sup> March 2020 due to the Covid 19 Pandemic the United Reformed Church Annan continued to make a contribution to the **Ministry and Mission Fund** which in 2020 totalled £18,192 (2019 - £ 16.200)

*Church Buildings and Manse:* Having been advised by the National Synod of Scotland that as the United Reformed Church Annan retained the Church Title Deeds at the time of Unification in 2000 then the church buildings & manse are owned by the local church i.e. The United Reformed Church Annan & as such the Church Buildings & Manse are included as an asset on the Statement of Balances.

The local church (United Reformed Church Annan) is responsible for the maintenance of the buildings ensuring that they remain wind and watertight. Any structural or cosmetic changes to the buildings can only be carried out with the approval of the National Synod of Scotland.
