## WHAT TO DO IN THE EVENT OF A FLOOD

In the event of a flood, there are many authorities available to help. Below outlines who should be contacted for the various types of flooding incidents and emergencies that occur. The local authorities rely on information reported to them to inform any investigations and prioritization of investment. If it is an emergency and there is danger to life as a result of flooding, you should not hesitate to call 999

To report flooding of the highway and blocked drains contact Devon County Council's Highway Customer Service Centre on 0345 155 1004 or visit the Roads and Transport webpage. Office hours are Monday to Friday 8am – 8pm and Saturdays 9am – 1pm. For emergencies outside of these hours call 01392 383329

For any flooding on major trunk roads (the M5, A30, A38, A35 and A303) contact the Highways Agency on 0300 123 5000 (24 hour service)

To report flooding from sewers and water pipes contact South West Water on 0344 346 2020 (24 hour service)

For enquiries about flood warnings contact the Environment Agency's Floodline on 0345 988 1188 (24 hour service)

For general enquiries about Main River or flooding from the sea contact the Environment Agency on 03708 506 506

For all other flooding enquiries contact the Devon County Council Flood Risk Management Team on 0345 155 1015 or email [floodrisk@devon.gov.uk](mailto:floodrisk@devon.gov.uk)

## **Vicar's article**

### **What is Christmas all about? What is its wonder?**

UA Fanthorpe (see below) wrote this wonderful poem from [\*Christmas Poems\*](#) (Enitharmon, 2002) entitled **BC – AD:**

#### **BC – AD**

*This was the moment when Before  
Turned into After, and the future's  
Uninvented timekeepers presented arms.*

*This was the moment when nothing  
Happened. Only dull peace  
Sprawled boringly over the earth.*

*This was the moment when even energetic Romans  
Could find nothing better to do  
Than counting heads in remote provinces.*

*And this was the moment  
When a few farm workers and three  
Members of an obscure Persian sect*

*Walked haphazard by starlight straight  
Into the kingdom of heaven.*

[U A Fanthorpe, 2002]

A congregation member sent me a different poem, not about Advent or Christmas, by Stevie Smith;

<https://www.poetryfoundation.org/poems/46848/thoughts-about-the-person-from-porlock> in case you're interested. I thought about quoting it, but we both felt the irony needed too much explanation.

There is irony in UA Fanthorpe's poem – the “dull” peace for example – but it is understated in contrast to its sense of wonder.

It's fairly Biblically-based – I love her description of the time when “*Before turned to After*”. We live with that in our use of BC and AD, don't we (even when BC is changed to BCE).

There is debate about the census (certainly about going to the home town of your birth: can you imagine the chaos?), the Magi may well not have been “three”, but they were indeed “members of an obscure Persian sect” - perhaps astrologers (forbidden in Jewish law), probably not “kings”, but important people.

And I love the description of the shepherds as a “*few farm people*”; as I have said before, they would have been lowly, despised even, in the culture of the day, as they couldn't observe the Temple laws of attendance and purity, owing to their work – which was potentially dangerous as well.

But I am preaching too much, in danger of being nitpicking, and ignoring the message. The visitors to the crib

*“Walked haphazard by starlight straight  
Into the kingdom of heaven”.*

What a wonderful description! So can we! That is the real wonder of Christmas (not food or money), but that we too, this Christmastide can walk ‘straight into the kingdom of heaven’ - I pray that you do too. If you can, experience a tiny bit of “wonder” at one of the local church services.

Thank you so much to the wonderful people of Exeter for the brilliant response we have received! It's always so heart-warming to get a large number of replies. Below is some information about what to include and where and when you can drop off your donation. Please email me if you have any questions at all.

#### **What goes in the bag?**

The list is fairly simple and is on the flier, but please note – we cannot give away anything which contains any alcohol. This is true whether it is only in mince pies or cake. We must stick to this, so please check your donations.

We suggest each bag may contain:

- Christmas cake
- Yule Log (within date for the 25<sup>th</sup> of Dec)
- Sweet pies (mince or other)
- Biscuits (something a bit posh!)
- Crisps, nuts and or savoury crackers
- Box of Christmas Crackers for family bags
- A small family game (like cards, dobble, uno, charades or similar)
- A couple of bottles of soft drinks
- Bag of sweets

You can add a couple of things or miss a couple. This may be the only gift that some people get, which is why we said 'posh' biscuits! We hope that these really will be treats for people.

We hope to have *small bags* (which are for singles) *Medium Bags* (for couples) and *large bags* (for families of 4ish). Please mark on your bag if you feel it is small, medium or large.

We are asking for 'bags for life'; ideally the more canvassy/heavy-duty ones as they stand up better and are easier for us to store! They also look much nicer for the client.

You can add a **greeting card** – but please don't put your surnames/phone no/address on it. Please don't seal them as we may also be adding some vouchers to them. Cards are optional.

Some of the bags will be given by our partners at The Beacon Centre where we run a foodbank session. Some may be given to families in Broadclyst and Cranbrook where we also take weekly boxes.

We have had a couple of other charities who are working with families and younger and older people who have seen this and called us saying *'if you have any spare, please.....'* So, we will share if we have your permission.

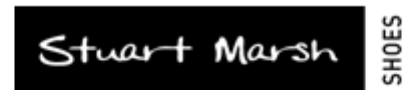
