

# Weedon Bec Parish Council Working Group - Status Report 24 June 2013

## Weedon Parish Council Working Group and WSA meeting:

WSA extended meeting request with the group for Thursday 27<sup>th</sup> June with a second option of Tuesday 25<sup>th</sup> June.

An agenda had been drafted so that the Work Group could be brought up to date with progress etc and to visit site to highlight proposed build area/access etc

The meeting request was declined by the work group on 17/6 as the dates were not suitable and WBPCWG will look to see what is possible. No further communication received from Working Group regarding alternative dates.

## DDC Pre-Planning:

WSA Architect has finally received the report/letter from the Planning Officer reference the Pre-Planning meeting held in Dec2012/Jan 2103 (outstanding since January 2013) - this is a particularly disappointing 'service' from DDC given the requested £300 to undertake this consultation.

Pre-Planning meeting is intended to assist with the planning application submission in respect of advising all items expected to be included plus consultation with external bodies.

## <u>Lease</u>

The Land surveyor has been able to move forward with the requirements for the lease and this is now with WSA for final review. This has taken into consideration the work areas that would be required during the build as well as the occupation area required by the building and access areas.

Appointed solicitor will now need to consider the surveyors findings to allow comment and advice on proposed lease application to WBPC

Lease proposal drawings will be issued to WBPCWG for discussion when agreed by WSA and Lease/Solicitor team

## **Planning Application preparations**

Heating and ventilation scheme guidance for the new community building is being provided via Pro Help appointed Consultant BSD of Corby. Information now provided regarding requirements for Heating etc after meeting in Mid May. This needs to be translated for the planning drawings and report.

## Additional scheme preparations

Report detailing play equipment including photographs completed to include as part of the re-site requirements



Investigations to resolve shutter specifications ongoing

Investigations to resolve roofing material ongoing - dependant on M&E outcomes

Street scene montage to be considered - the cost has been determined at £500 – WSA to make a decision if to proceed

Flood Risk Report - some amendments being included to report based on feedback

Design and Access statement 95% complete - this requires the final part of the heating and venting consideration to be included

Final scheme drawings 95% complete for planning submission. Heating and ventilation considerations for plant, install position to be included into submission drawing

Planning and Heritage reports to consider
